Event Schedule & Information

Friday, August 2nd

Practice

I will open the range for practice from around 10am-3pm. Please let me know if you're coming and what you want to get sighted in for. I will build the practice schedule and squadding around what the majority of competitors needs are.

Saturday August 3rd, 8am

Midrange Position Match

MR-POS course of fire

Match #1 is 10 shots @ 200 yards, offhand

Match #2 is 10 shots @ 300 yards, sitting or kneeling

Match #3 is 10 shots @ 600 yards, any position

Match #4 is aggregate total of Match #1, #2 and #3

Sunday, August 4th, 8am

BPTRA Midrange Prone Match

MR-ANY-500 Course of Fire

Match #5 is 10 shots @ 300 Yards

Match #6 is 10 shots @ 500 Yards

Match #7 is 10 shots @ 600 Yards

Match #8 is the aggregate of Match#4 & Match#8

Rules

BPTRA rules for each course of fire will govern BPTRA Midrange Championships unless posted otherwise by the Match Director.

Entries

All entries and payment must be received by July 29, no exceptions.

Please send your entries in as early as possible for the planning of the potential meal, target prep and match planning.

Squadding and Scoring

Squadding will be done in groups of 4 for both matches. All competitors will be expected to spot and score for their shooter. All competitors must inform their scorekeeper when going for score. All competitors will be responsible for pulling targets and pit duty unless otherwise arranged with the Match Director.

Jury

A jury of 3 entered competitors will be picked by the Match Director. The Jury will act and make decisions in accordance with BPTRA Rules.

Shooters Meeting and Scores

There will be a shooters meeting every day before shooting starts at 7:45am.

Once scores have been posted and competitors who are present have been informed, you will have 15 minutes to protest.

Awards

Awards will be based upon number of competitors overall and in each class and category. The Match Director will determine if there are enough entries in each class to warrant an award or awards.

- Certificates will be given for daily awarded categories.
- 1st, 2nd and 3rd overall will be awarded in the aggregate of each days match.
- High Spotter will be awarded in the aggregate of each days match.
- 1st, 2nd and 3rd will receive a trophy in the grand aggregate on Sunday.
- High Spotter will also receive a trophy in the grand aggregate on Sunday.

Dinner

Depends on the number of entries. I will update competitors as entries come in. It will not raise the cost of entry fees either way.

Accommodations

Camping is free on the range

Limited first come, first serve for RV spaces that have electrical hookups. Access costs \$5 and you can include this in your entry fee or pay separately.

There is water available at the Ranch House on the CRC Property.
