

# Privacy Policy for Red Knights MC Chapter LA 5

**Effective Date:** April 8, 2026

This Privacy Policy outlines how the Red Knights Motorcycle Club (RKMC) Chapter LA 5 collects, uses, and protects information provided by members and visitors to our website, [www.redknightsla5.org](http://www.redknightsla5.org). As a non-profit organization of firefighters who ride motorcycles, we are committed to protecting the privacy of our brothers and sisters in the service.

## 1. Information We Collect

We may collect personal information that you voluntarily provide to us, including:

- **Membership Details:** Name, address, phone number, email address, and fire department affiliation provided during joining or renewal.
- **Communication:** Information provided when you contact chapter officers or sign up for newsletters.
- **Event Registration:** Details provided when registering for rides, fundraisers, or regional meetings.
- **Technical Data:** Our server may automatically log your IP address and browser type to help diagnose problems and administer the site.

## 2. How We Use Your Information

The information collected is used solely for the administration of Chapter LA 5. Specifically, we use it to:

- Maintain accurate membership rosters.
- Distribute "Member Only" communications regarding rides and meetings.
- Process event registrations and chapter dues.
- Verify eligibility for membership based on firefighter status.

## 3. Information Sharing and Disclosure

- **Third Parties:** We do not sell, trade, or rent your personal information to outside marketers.
- **International Organization:** We share necessary membership data with the Red Knights International Firefighters Motorcycle Club (RKIFMC) to maintain your standing within the global organization.

- **Legal Requirements:** We may disclose information if required to do so by law or to comply with legal processes.

## **4. Data Security**

We implement a variety of security measures to maintain the safety of your personal information. Access to member data is strictly limited to authorized chapter officers—specifically the **President, Vice President, Secretary, and Treasurer**—who require the information to perform their specific duties and ensure the smooth operation of the chapter.

## **5. Third-Party Links**

Our website may contain links to other sites (e.g., the International RKMC page or event sponsors). Chapter LA 5 is not responsible for the privacy practices of such other sites. We encourage users to read the privacy statements of any website that collects personally identifiable information.

## **6. Images and Media**

As a social motorcycle club, we frequently post photos and videos from rides and events. By participating in Chapter LA 5 events, members acknowledge that their likeness may appear on the website. If you wish for a specific photo of yourself to be removed, please contact the Webmaster.

## **7. Your Rights**

Members may request to review the personal information we have on file or request corrections by contacting the Chapter Secretary.
