Christmas tree fundraiser totals emailed to fundraising participants. Banking needs to be completed to provide current totals. Some past event funds still require processing. \$7450 held for athletes, not accounting for funds yet to be deposited. \$2000 in social fund.

Canadian Tire is no longer suggested as a location for table sales based on management's decisions on where the table can be setup as the location is not very good for foot traffic/sales interest.
