f. Future Events:

- i. AGM June 2, 2025, Fargo. Future AGMs are suggested as being tied to an open gym, possibly on a weekend, to allow for kids to be in open gym while parents attend the meeting. Likely consideration for 2026.

- ii. Athlete Party: June 21, 2025

Ashley suggested using the parking lot area in front of the Motion business on the southwest corner of the parking lot, if wanting to have an outdoor space. The lot in front of the Hopes entrance is not available.

Board decided that after the showcase, athletes will be provided with pizza, sundae bar, an athlete gift (if cost allows, TBD) and open gym. Party expected to begin ~ 6 PM.

Concession to be closed after second show begins 4:45.

Wristbands to confirm payment/registration. Board members mark wristbands with 'P' when the athlete receives their pizza slice, 'S' when they receive their Sunday, 'G' when they receive their gift (again, if costs allow).

Pizza in the lobby on the rec side, cycle through kids and then as kids are finishing pizza, they can move over to the comp side to make sundaes.

Cost \$15 for non-DGPA athletes/siblings. Parents can drop off or stay and if wanting food (pizza & pop), \$5 if eating. \$2/slice for additional pizza.

Costco pepperoni pizza and cheese pizza, Cosmic ham and pineapple pizza by delivery.

Water bottles w/stickers as athlete gifts - minimum of 200 for the order, with option to print on bottles \$3/bottle). Light blue water bottles with dark purple top.

Shandra offering to be an open gym coach. Laurel to ask Carrie about providing coaches for the party free of cost.
