- Battalion Chief Cain Jr. asked about the mini pumper

Planning for Remodel/Addition:

- District Chief DeBruin spoke to the cost of a remodel or building a new station at the districts donated land at the Resource Center and having a feasibility study done and the cost of that study
- Commissioner Bjornstad indicated he would like to see the study done for helping with the decision process
- Discussion continued on pros and cons of a new location and building a new station or remodeling the station at Kendall Station

- District Admin Olson indicated she would have one ready for next month's commissioner meeting
