- Training Division Lieutenant Moe will submit his findings to the commissioners

City of Sumas:

• District Chief DeBruin had no news from the City of Sumas Kendall Remodel:

- District Chief DeBruin indicated there are still questions being brought up by the County about the remodel even though we have permits in place or in process
- District Chief DeBruin indicated it looks like we must use a point of capture system for vehicle exhaust
