IA 93:

- District Chief DeBruin indicated Initial Attack 93 is only pumping at about 50% compacity
- District Chief DeBruin said they will apply for a grant for funds to fix this issue especially since Initial Attack 93, outside of the pumping issue, is in really great shape
- District Chief DeBruin noted the grant opens up sometime in September

- District Chief DeBruin spoke to TriVan wanting to borrow A-91, the vehicle they made for us. TriVan would insure etc., as they would like to show it off at a Wenatchee Show they will be attending
