## Transport Fees:

- District Chief DeBruin spoke about transport fees being paid to the volunteers
- District Chief DeBruin suggested that our volunteer EMT's would get a set rate whether they were the EMT or Driver on a transport
- Also acknowledged some of our transports have been taking an increasing amount of time, especially when you go to the Mountain area and then all the way to town and our Glacier district transports take extra time as well
- Dollar amounts talked about were, Mountain Transports at 100 /70, and Glacier Transports at 90/60
- Commissioner Graham and Commissioner Bjornstad agreed with the higher dollar value placed on longer calls, which will be at District Chief DeBruin's discretion based on dollar amounts discussed

- District Chief DeBruin indicated it might be on the August 2, 2016 Primary Election ballot

- Discussed was the added safety of having a vest for visibility purposes
- District Chief DeBruin said he will look into it

## **Training Division Lieutenant Moe:**

### Transports:

 Training Division Lieutenant Moe indicated the district has transported 457 people this year as of the end of November

#### Red Card:

- Training Division Lieutenant Moe indicated South Whatcom is really interested in putting a Red Card Training class together, so between our district and theirs we should be able to get this worked out and get a class offered
- Discussion continued on the benefits of the Red Card Class

## **Fire Station Reports:**

- Station 1, Sumas Battalion Chief Jay Van Middendorp
  - Battalion Chief Van Middendorp indicated everything is going well at Sumas and we now have a new generator, which is working well for the Sumas Station
- Station 2, Kendall Battalion Chief Frank Cain Jr.
  - Battalion Chief Cain Jr. said all is going well at Kendall but noted they are low on personnel
  - Battalion Chief Cain Jr. said he still has issues with the volunteers and their attendance on training night
- Station 3, Welcome Battalion Chief Denise Christensen
  - Battalion Chief Christensen says all is going well at the Welcome Station she agrees attendance could be better
  - o Battalion Chief Christensen says they have a great group of volunteers
  - Battalion Chief Christensen indicated there is a light burned out at the Welcome Station

- o District Chief DeBruin said they will get the light replaced
- Battalion Chief Christensen discussed vacuum mattress and their ease of use
- Battalion Chief Cain Jr. reminded Battalion Chief Christensen to grab a cervical collar from the Kendall Station before she leaves tonight
