## Levy Lid Discussion:

- Commissioner Graham led the discussion on the levy lid and the need for more funds to continue supplying fire and EMS in the county
- Commissioner Graham asked the meeting attendees for their input on both current and future district needs and to prioritize them
- Discussion continued on the needs of the district
- Commissioner Graham decided to call special meeting in two weeks for all to review the prioritized list
- Commissioner Graham agreed to compile the meeting ideas and come up with a prioritized list to present at the special meeting

  - Battalion Chief Christensen indicated all is going well at Welcome
  - Battalion Chief Christensen indicated they have a new applicant whose already a truck driver so that's a plus

Thank you letter:

Cardiopulmonary resuscitation (CPR) Class:

• District Chief DeBruin indicated they provided a CPR class for the Border Patrol. The district will be offering more CPR Classes; one of which will be at the Resource Center and another one for the office of Tony Kelly

E93:

• District Chief DeBruin noted E93 is back up at HUB due to the pump housing packing leaking. They will be putting new packing in and hopefully it will be good to go

WSRB:

• District Chief DeBruin indicated he will be busy with the Washington Surveying and Rating Bureau (WSRB) meeting tomorrow

T92 Accident Replacement:

- District Chief DeBruin pointed out the cost of replacing T92 due to the accident it was in last Friday

- Commissioner Bjornstad seconded the motion
- Commissioner Graham asked how to handle coverage within the district right now, being one tender down
- Discussion continued on the vehicle logistics
