New Law for Sick Leave for Part Time Employees:

- District Administrator Olson spoke to new law for sick leave and part time employees
- Commissioners agreed with going forward with District Administrator Olson having the Wells Fargo payroll systems updated with sick leave time

Resolution 2018-02 Order Cancellations of Wells Fargo Payroll Warrants more than a year old

- District Administrator Olson spoke to the cancellations of checks over a year old
- District Administrator Olson stressed Direct Deposit would help end having to deal with checks not being cashed
- District Chief DeBruin said he and Training Division Lieutenant Moe will monitor checks are being cashed
- District Administrator Olson indicated they need to report any uncashed cheeks to unclaimed property, a process which she is looking into
- District Administrator Olson also noted letters will go out first notifying the uncashed check holders that they have unclaimed money due them
- District Administrator Olson also said they can do a stop check with Wells Fargo on the outstanding checks for a small fee
- A motion was made by Commissioner Moe and seconded by Commissioner Bjornstad to do a stop payment on checks over a year old
