Wells Fargo Business Checking/Public Funds:

- Wells Fargo indicated an Agreement to Terminate Interest can be signed and we would then have a non-interest-bearing account
- District Chief DeBruin agreed and indicated District Administrator Olson should sign the form
- District Administrator Olson signed form to terminate interest as we can not have an interest-bearing account, per the County

Kendall Station Remodel Options:

- Commissioner Moe gave hand-outs of modular building and future equipment cost for the district
- Commissioner Moe reported on the modular option for the district as well as loan options
- Discussion continued on the modular building options, site plan, permits, bids, etc.
- Commissioner Moe indicated he can make some more calls on the modular buildings
- Discussion continued on coming up with a plan and having it go out for bid
- District Chief DeBruin will look into the stick building option as well
- District Chief DeBruin and Commissioner Moe will work together on getting the information together on modular and stick building
- Battalion Chief Cain talked about the gravel area where it would be built and cost of the modular building

Battery Powered Jaws Units:
