1. The State Attorney General's office represents the state agency Texas Department of Criminal Justice in lawsuits. A good attorney helps clients "calculate the odds" of various positions. Over the past several years, the state has paid out many millions of dollars in lawsuits related to the need for climate control in Texas prison living areas. While some of the plaintiffs sought relief from temperature extremes because of current health issues, others sought relief on the grounds of basic humane treatment. Still other plaintiffs have been state employees who have to work in inhospitable temperatures and in a dangerous environment made still more dangerous by the violence and despair incited by torturous conditions of inhumane temperatures. Other lawsuits against TDCJ have dealt with healthcare for inmates, including the need for dentures, inadequate care for kidney disease, and other chronic illnesses. In the case of one lawsuit, seeking humane temperature control for the Wallace Pack Unit, published accounts show that costs to fight the case were almost double the amount finally spent to provide climate control for the unit.
