



# Campground Rules & Guidelines

- **Check out:** 11am – **Check in:** 1pm
- **Quiet hours** – 10pm-8am (*All children expected to be at their campsites by 10pm.*)
- **Speed limit-** For the safety of our guest's speed limit is 5 mph and will be strictly enforced.
- **Playground** – is for children 10 & under, children MUST be accompanied by an adult, NO food or drink in playground area.
- **Pets** – \***Pet pens or corrals MUST be approved by owners/staff of The Meadows**
  - Domesticated pets ONLY
  - Only 2 pets per site
  - All pets must be on a 6' leash or shorter when outside of your RV
  - Pets are NOT permitted in store, bathhouse or laundry
  - Pet owners are responsible for cleaning up after pets
  - Pet pens or corrals are NOT permitted
  - It is a campground policy that all pets be vaccinated
  - Pets are NOT allowed in playground area
  - No excessive barking or aggressive behavior allowed
- **Pond** – Swimming, wading and the use of floatation devices in pond is PROHIBITED. All children MUST be accompanied by an adult when visiting pond area.
- **Parking** – (1) RV & (1) automobile per campsite, any extra vehicles must be parked in overflow parking. DO NOT PARK on GRASS!
- **Rugs/Carpet** – No rug or carpet is permitted on the grass for any reason.
- **Canopy** – Only (1) canopy will be permitted at your campsite.
- **Smoking** – NO SMOKING in the camp store, laundry, bathhouse or playground area.
- **Sewer Connections** – All sewer connections must have an airtight seal & be above ground using a sewer hose support.
- **Early Departures** – NO REFUNDS will be given for early departures or acts of nature.
- **Grills** – DO NOT place grills or cooking elements on picnic tables.

- Children **MUST** be supervised at **ALL** by a parent or guardian.
- Please keep children away from campground displays such as, silo, ox cart, antique truck, etc.
- Parents/Guardian is responsible for the safety and behavior of their children.
- Please ensure that children do not disturb other guests.
- **Flooding or severe weather-**
  - Guest are **REQUIRED** to remain near their RV so that he or she can ascertain whether their RV will need to be moved.
  - Guests are **REQUIRED** to stay informed about inclement weather and weather alerts issued by the National Weather Service (NWS).
  - If a flood advisory or inclement weather advisory or warning has been issued, guests are required to remain near their RV do that he or she can ascertain whether their RV will need to be moved.
- **Freezing Temperatures-** It is the campers' responsibility to wrap their own hoses/pipes.
- **Trash** – A trash dumpster will be provided on site. Please take all trash to the dumpster daily to avoid wild animals.
- **Sites**
  - Please keep all sites neat & tidy. We have a beautiful campground, and we want it to look the best for you and others.
  - Six (6) persons maximum per site
  - No excessive number of items to be left outside RV
  - Clotheslines are **NOT** permitted.
- **Valuables** – Please secure your own valuables, the owners of “The Meadows” at Double Creek RV Resort will **NOT** be held liable for loss or theft.
- **Campfires** – Fire rings are provided at all sites. Firewood can be purchased at camp store.
- **Drugs** – **ZERO TOLERANCE** of drug possession or drug use on property.
- **Alcoholic Beverages** – Are not allowed outside of your campsite.
- **Subletting** – At this time, we will not be subletting.

- **Background checks**- Background checks on any long-term campers.
- **Camping Etiquette** –
  - Please respect your fellow campers' privacy by NOT walking thru their campsites or creating loud noise. Please refrain from loud cursing. We want to keep our environment family friendly.
  - Please USE CAUTION around campsites, pond, creeks and any of our natural area. Rocks can be sharp or slippery. Be careful of uneven ground which can cause twisting of an ankle or fall, climbing on banks will NOT be allowed. Be aware of poisonous plants & harmful critters.
  - If you have any concerns about water quality in either creek, please do not enter, or do not allow your family or friends to enter.

Our campground is considered as an “Enter at Your Own Risk” campground. The owners and staff at “The Meadows” at Double Creek RV Park are NOT Responsible for any injuries, thefts, accidents, sickness or deaths that occur on the premises.

Camping is inherently dangerous due to the risks related to the outdoors. So please be safe, play safe and if you see anything that needs to be addressed, please let us know.
