I _____ hereby agree to hire Alicia Chaulk/The Horse Shopper. I agree to pay all fees outlined in the services and rates document provided to me, for which I will incur over the period of hiring The Horse Shopper. I agree to pay a non-refundable deposit of \$150.00. If I do not pay the total sum of the invoice sent to me by The Horse Shopper within 15 days of receipt, I acknowledge that 5% of the total bill will be added on every 30 days from receipt.

If I choose to privately sell a horse that The Horse Shopper has advertised/shown for me directly to the buyer, as well as if I choose to privately sell a horse with marketing materials created by The Horse Shopper, I acknowledge that The Horse Shopper is still entitled to bill me a commission fee, which I agree to pay.

I will not hold Alicia Chaulk, and/or The Horse Shopper liable (not limited to but including, injury, harm, damage and death caused during and after the process & purchase to both horse and human) I acknowledge that The Horse Shopper/Alicia Chaulk simply acts as a mediator between buyer and seller, and cannot guarantee a horse's soundness, represented state, riding ability, age, breed, etc. as this information is the responsibility of the seller/owner.

If I choose to purchase a horse back from the buyer, the transaction will purely be between buyer and seller, and the commission fee and other service charges from The Horse Shopper will not be refunded. The Horse Shopper is willing to work with their clients on reselling the horse if this instance occurs (if desired).

I agree to leave my credit card information on file with Alicia Chaulk/The Horse Shopper, and acknowledge that if my total bill is not paid 60 days from receipt, The

Horse Shopper will charge the balance to my credit card + a 2.5% processing fee. A blank signed cheque addressed to Alicia Chaulk may be used in place of a credit card.
