Report from Ingleside Precinct, SFPD

Captain Nicole Jones reported that in May and June violent crimes were down, although burglaries were up. Garage break-ins continue to be a common crime; people gain access to garages by stealing the garage door opener or simply breaking a window. Captain Jones encouraged people to install video cameras or bright lights around the garage if possible. She also recommended keeping your landscaping cut back so there is no place for a thief to hide.

The Cayuga neighborhood specifically has seen an increase in cases of car tires and wheels being stolen, as well as catalytic converters. She noted that working on a car on the street is illegal, so report those incidents.

Captain Jones also noted that stunt driving events continue to become more brazen. When these events are broken up, the cars get towed. The cars are held for a longer time and the owner is assessed significant fines.

Report from Daniel Amador, Assistant S.F. District Attorney daniel.amador@sfgov.org

Mr. Amador is in the Special Prosecutions Unit, White Collar Crimes Division, of the DA's office. He told us about the Community Liaison Program, which he is a member of. It's a group made up of Members of the DA's office, such as investigators and prosecutors, who volunteered for this program. There are 3 members for District 11. They serve as a liaison between District 11 constituents and the DA's office, and attend Supervisors' Meetings as well as neighborhood meetings to get different perspectives on issues. It's not an investigative unit; after a crime has been committed and someone is charged with the crime, this group can talk to witnesses or victims, and answer general questions about the case. They can connect those people to Victim Services, and collect feedback about the DA's office.

Report from Sarah Quinones: San Francisco Transit Riders

The San Francisco Transit Riders is a grassroots, membership organization, founded in 2010, working with SF Muni and the Metropolitan Transit Authority. They have been working to get the bus routes re-established that were taken offline during the pandemic. They are also interested in helping with any quick fixes that might be necessary, such as blocked stops, missed stops, etc. Ms. Quinones encourages people who use Muni and are familiar with it to join the group;

He also met with Vince Yuen who leads "Refuse Refuse SF", (info@refuserefusesf.org - https://refuserefusesf.org) a grassroots clean up team that has created a model for cleaning up his neighborhood that can be copied in other areas. He can also provide supply kits.

Friends of Cayuga Park:

Continuing on the clean up theme, Chris Dillon reported that July 31 will be a cleanup day for Cayuga Park. She will send out details as they are finalized.

She also reported that a very successful book launch was held last week, celebrating the release of Yoni Carnice's new book, "Sunlight Entered His Hands". We plan to hold a second book launch, date to be determined.

Resilient Cayuga:

It was suggested that we hold a safety program, with emphasis on the AAPI community, sometime this fall perhaps.

Community Outreach/Membership:

Jane Merschen had 1000 flyers printed up about our meeting and various members distributed them throughout the community. It was emphasized that it's critical to increase membership to keep City Hall's attention and get our needs met.
