



Vendor Guidelines and Application

LOCATION: The show is located at the Cottrellville Township Park on Short Cut Rd. This is an open-air show which takes place rain or shine (no rain date).

SHOW INFORMATION: Friday, August 15, 2025, from 5:00 pm – 10:00 pm and Saturday, August 16, 2025, from 12:00 pm – 10:00 pm.

BOOTH INFORMATION: Booth spaces are approximately 10' x 10'. Booths will be numbered, and hash marks will indicate the perimeter of the booth. Vendors will be assigned a booth space, however the Event Committee/Staff and Township Staff are not responsible for providing

tents, tables, chairs, or other equipment. Electricity is not available at the park. If electricity is needed, please be sure to indicate your needs on your application, and you will be responsible for bringing your own quiet (below 50 decibels), low emission generator. Vendors will not be assigned a booth space until payment is received in full. If additional space is needed, then another vendor space must be purchased in advance.

SETUP: Vendors may begin setting up 2 hours prior to the opening of the event. Vehicles will be allowed to drive into the vendor area during the first hour of setup but must be moved off site 1 hour prior to the start of the event. Early or late arrivals will only be accepted with prior approval. Vendors must be ready to open at the start of the event and should not close early, unless Event Committee/Staff or Township Staff closes the event for extenuating circumstances.

DURING EVENT: Vehicles will NOT be allowed to enter or exit the vendor area during the posted event hours. If you need to bring in or remove any belongings during this time, you will have to use your personal hand cart, wagon, or dolly to do so. All vendors are responsible for securing their booth and cleaning up during and after the festival. Vendors must place garbage in the park dumpster as trash cans are reserved for event goers. There will be overnight security on-site Friday night, however The Event Committee and/or The Township of Cottrellville do not carry additional insurance to cover your personal property and are not responsible for any lost, stolen, or damaged property. You may leave your booth structure intact overnight, and merchandise may be left inside, at your own risk.

TEAR DOWN: Vendors are responsible for removal of all boxes, trash, etc. All vendors must vacate the park by 11:00 pm on Saturday, August 16, 2025.

MERCHANDISE: This is a family friendly event! Vendors may sell merchandise, memberships, subscriptions, etc., identified on the application and approved by the Event Committee, so be specific! The Event Committee and/or the Township Staff reserves the right to deny any vendor for any reason and reserves the right to stop the sale of such items it deems inappropriate. Prohibited Items Include but are not limited to firearms and explosives, sales of live animals, offensive or obscene materials, alcohol, tobacco, marijuana and drug-related paraphernalia, and illegal or illicit items.

REFUND POLICY: The Event Committee and/or the Township Staff reserves the right to deny any vendor for any reason. Submitting an application does not guarantee approval or inclusion at *Hoods, Tunes, & Brews 2025*. If you are not approved, your fee will be returned. Once a vendor is approved fees are non-refundable in the event of vendor no-shows or weather. Refunds will be issued for cancellations requested at least 14 days before the event. However, we cannot offer refunds for requests made within 14 days of the event.
