Releasor desires to engage in equine activities sponsored by, or in which Releasor will be using equipment, facilities, and/r premises furnished by, Releasee. Releasor understands there are inherent dangerous risks of serious injury or death in equine activities. As a condition of participating in equine activities, Releasor (individually and for his/her heirs, executors, assigns, invitees, and minor children) waives the right to bring, and releases Releasee and Releasee's administrators, agents, officers, directors, employees, predecessors and successors-in-interest, and any other persons or entities united in interest with Releasee from any and all manner of actions, suits, claims for relief, demands, damages, and any other obligations, known or unknown, suspected and unsuspected, in law or equity, direct or indirect, and whether now or in the future, for any injury or death arising out of or connected in any way with riding, training, driving, barding, grooming, or riding as a passenger upon an equine. If for any reason any provision of this release is determined to be invalid, the remainder shall continue in full force and effect. This release contains the entire agreement between the parties hereto and the terms of this release are contractual, not a mere recital. Signing this release is evidence of my acceptance of the provisions held within.
