

## **A.E.F.T. GAMING PRIVACY POLICY**

This Privacy Notice is designed to help you understand what information we and third-party's may collect, why we collect it, what we do with it and your rights when registering, using or accessing the A.E.F.T. Gaming Platform, ("Platform").

### **INFORMATION WE MAY COLLECT FROM YOU**

- Your name, email address, address, telephone number, or other contact information you provide to us.
- Your transaction id, amount of payment, date and time of payment, offer accepted and other payment or subscription related information.
- Your account name, platform ID, profile picture and other information from a platform when you choose to link or log-in with a third-party platform and A.E.F.T. Gaming.
- Other information you give us in-game, via email or web forms, including upon our request.
- Information that you publish on your user profile or which you post on in-game message boards. Please note that information that you voluntarily make public in your user profile, or which you disclose by posting comments will be publicly available and viewable by others. We do not have any liability for any information that you voluntarily choose to be public and/or other explicit actions.
- We may receive personal information if you choose to link or sign-in with a third-party platform to access A.E.F.T. Gaming. Exactly what information we receive from your platform will depend on your platform's privacy settings.
- We may receive personal information about you from third-party sources, such as from platforms that the games run on or payment "Platform" providers (for example, to verify payment), or demographic data (such as your gender or age range).
- When we collect personal information, we do not know the age of our players. We do not knowingly collect or solicit personal information about under the age of 18. If you believe that we might have any information from or about a child under the age of 18, please contact us and we will delete that information as quickly as possible.

## **WE MAY USE THIS INFORMATION FOR LEGITIMATE BUSINESS PURPOSES**

- To create user accounts / profiles to enable you to play our games and use our “Platform”, where necessary;
- To provide, deliver and operate products and services you request.
- To enable you to communicate with other users.
- To send you service-related communications (for example changes, updates, new features).
- To verify and confirm payments. We do not collect or retain credit card information; our payment service providers will provide us with information about your purchases so that we know if a purchase has been successful.
- To respond to your customer support requests.
- We may process your personal data in order to organize and communicate with you regarding contests, tournaments, events and competitions, as well as to determine the winner and deliver the prizes. If you wish to participate in our contests and competitions, you must provide us with the requested personal data. If you refuse, unfortunately, we will have to disqualify you. We may also publish the names and entries of entrants. That information may also be combined with your account information and will be processed in accordance with this Privacy Notice.
- We may process your personal information for legitimate internal administrative purposes.

## **SHARING INFORMATION**

In addition to other specific situations discussed elsewhere in this policy we may disclose information with your consent, to respond to any legal process, to comply with relevant laws, to defend against a legal claim, or to comply with your request for shipment of products by a third party or entity.

Any information you submit while using the “Platform” should be considered by you as publicly available information.

We may share your information with service providers for Platform assistance that may help administer our website, provide technical support, process payments and assist in fulfillment of orders.
