## Stallion Service Agreement

By entering into this Contract the Owner agrees to the following:

1. **I Hereby agree to breed my mare:** \_\_\_\_\_/Reg.# \_\_\_\_\_ to the Stallion:  
**PYC Fun N Fancy** either on-site at Dunn Ranch or by shipped cooled or frozen semen during the 20\_\_\_\_ breeding season. I agree to pay \$ 2500.00 made payable to Dunn Ranch for the stud fee. The stud fee is paid in full prior to semen shipment. Mares bred on-site at Dunn Ranch will require a booking fee of \$750.00 (which is a non-refundable down payment on the Stud Fee) paid prior to breeding. The remainder of the stud fee must be paid before the mare is bred at Dunn Ranch or semen is shipped.
2. If mare is to be bred with shipped semen, I understand that the Stud Fee must be paid in full before any semen will be shipped. I agree to pay a fee of \$300.00 per Standard Overnight Delivery, \$150.00 for each local pickup , \$450.00 per Counter to Counter Airline Shipment, or \$500.00 for each frozen semen shipment. Every attempt will be taken to deliver the semen to mare owner in good condition, but once shipment leaves Dunn Ranch, they cannot be held responsible for untimely delivery or condition of the cooled semen. I am also aware that the on site mares will receive priority, and all Shipped Semen mares will be serviced on a first order, first serviced basis if necessary, therefore there is No Guarantee that semen will be available for any specific day. Semen orders will be requested by 5pm CST the day prior to semen collection, and cancelled by 8 am CST the day of collection, it will be left to Dunn Ranch to determine if charges are incurred. For Canadian shipments , please contact our office for additional instructions and fees. All Semen containers MUST be returned within 5 business days of receipt. If the container is not received within 5 business days the mare owner shall pay a NON- RETURN fee of \$30.00.
3. Stud Fee does entitle mare owner a Live Foal Guarantee. I am entitled to a "live foal" conceived from this breeding that will stand and nurse after foaling with out assistance and live for (24) hours. If my mare is found to not be in foal, or delivers to a stillborn, I am allowed a Rebreed Contract as long as Dunn Ranch is notified with in (30) days of discovering the mare is open or foal is stillborn. With this notification there must be a statement from a licensed veterinarian. A Rebreed contract will apply to the following breeding season only, and the stud fee will be nonrefundable. Live Foal Guarantee will be null and void if mare owner does not give ample opportunity to settle mare. Stallion owners will also be released from Live Foal Guarantee if mare is sold without notifying the Stallion Owner and providing the new owners contact information. With Rebreed agreement I am required to pay for all mare services and all other veterinary related fees and board.
4. If mare is bred onsite , I agree to pay in full all charges including , veterinary expenses and board charges before my mare shall be released from Dunn Ranch. Dunn Ranch has permission to breed and treat my mare however deemed appropriate to complete this contract. I am aware that this is a non-chute fee contract and I will be responsible for payment of all services rendered. Which include all palpations/reproduction ultra sounds, \$150.00 semen collection for on-site breeding, artificial inseminations, and all other treatments/medications utilized to breed my mare. I am also aware the stallion owner is not held liable for charges rendered to breed my mare. I fully understand that Dunn Ranch will diligently try to settle my mare, or produce an embryo to transfer, but if they are not able to Dunn Ranch shall be held harmless.
5. Mare Owner agrees to notify Dunn Ranch of the pregnancy status of the mare by August 30<sup>th</sup>, 2019. Mares with an unknown pregnancy status will not be included on the stallion breeding report and could be subject to a \$50 stallion breeding late filing report fee.
6. If the mare produces more than one embryo from a Stallion breeding under this said agreement and if more than one embryos are transferred , the Mare Owner must notify the Stallion Manager within 48 hours of transfer of embryo(s). If embryo transfers result In multiple pregnancies, then the Mare Owner must pay the Stallion Manager the Stallion Stud fee

7. for each pregnancy in the amount of \$2500.00. Mare Owner acknowledges that only one foal may be registered as a result of the insemination of the Mare this agreement regardless of the number of embryos or live foals that might result from such insemination.
8. It is also agreed that if the mare dies before producing a live foal or becomes unfit to breed before being pronounced safe in foal, a substitute mare will be allowed for the current breeding season or the following season only. No Stud Fee will be refunded. In case the stallion becomes unserviceable for whatever reason, Stallion owner will utilize frozen semen if available to satisfy the contract for (1) year following the season the stallion is deemed to be unserviceable.
9. It is my understanding that care will be taken for both the mare and / or foal presented to Dunn Ranch, to prevent accident, sickness, injury , or death, and that the mare owner will not hold Dunn Ranch, its owners, employees, the stallion owner , or any other employees responsible if any such occurrences occur. It is understood that Dunn Ranch , its owners employees, veterinarians, and guests shall not be held liable for any injury, escape, disability, or death of any horse on its premises whether from fire, flood, act of God , theft or any other reason.
10. Dunn Ranch and Stallion Owners will have a necessary lien for all fees, charges, and expenses that are incurred while the mare and / or foal are under the care of Dunn Ranch. Mare owners are to be responsible and agree to pay all legal fees and /or attorney/court costs incurred by Dunn Ranch or the affiliated Stallion Owner to enforce this agreement or any portion of it. It is agreed that this contract is performed in Garvin County, Oklahoma and venues for any actions hereunder will be in Garvin County , Oklahoma.
11. NO mare will be bred, and semen will NOT be shipped without a completed Stallion Service Contract that is signed by the Mare owner and Stallion Owner or Agent of Stallion Owner. At this said time, the contract will be a binding contract on both parties, subject to the above said terms and conditions.
