## INDEPENDENT CONTRACTOR SUB-HAULER AGREEMENT

This Independent Contractor Agreement is entered as of thisday of	_20
By and between Rausser Bros. Trucking, Inc. and	

The parties have agreed to the following terms and conditions under which the terms of Such transportation shall be performed.

NOW THEREFORE, in consideration of the promises and mutual convents herein set Forth the parties agree as the following:

**Subhauler**: is declared to be an independent contractor and has no authority to act for Or on behalf of Broker, or to bind the Broker to any contact without the express written Approval of the Broker.

## Insurance:

- **A.**Commercial General Liability Insurance \$1,000,000 Combined Single Limit Commercial General Liability insurance coverage shall be in a amount equal to or greater than 1,000,000 per occurrence combined single limit. Said commercial general liabliity coverage shall provide coverage for bodily injury, property damage, personal injusry, contractual liabilities and advertising injury.
- **B**.Commercial Automobile Liability Insurance \$1,000,000 combined single limit automobile liability insurance coverage shall be in an amount equal to or greater than \$1,000,000 per occurrence combined single limit. Automobile liability

coverage shall provide coverage for liability arising out the use of any auto as defined by symbol 1 of the insurance services office's business auto coverage form. Said automobile liability coverage will alson include pollution liability coverage for cargo (CA 9948 or equivalent) and a MCS 90 endorsement if required for the transportation of hazardous material.

- **C.** Cargo Liability Insurance Cargo liability insurance, covering goods on any trailer or equipment whether or not identified, shall be in an abunt equal to or greater than \$100,000 per occurrence for damage arising out of any one occurrence to property transported hereunder.
- **D.** Comprehensive and collision coverage insurance If contractor uses any Rausser or G3 equipment comprehensive and collision coverage will be provided via a trailer interchange endorsement, or other equivalent coverage endorsement, with limits equal to the net replacement value for all trailer and any other equipment that is owned by Rausser or G3.
- **E.** Worker's Compensation Insurance If you have drivers, coverage shall provide statutory limits of coverage within the state of employment and any state in which cotractor is to perform any aspect of this agreement. Worker's compensation insurnace policy shall maintain employer's liability insurnace in an amount equal to or greater than \$1,000,000 each accident.

**Performance:** Performance is the essence of the agreement, the broker shall provide Subhauler with scheduling information and subhauer shall confirm to Schedules provided by broker. Subhauler agrees to begin work promptly as scheduled As requested by broker to perform diligently,in a safe manner, in good faith and full Cooperation with broker and with broker customers and complete the work as requested By broker. Failure to maintain the performance standard herein set forth shall give broker The right to terminate this agreement in the interest of protection its reputation and Reliable transportation services to its customer.

Invoice Requirements: Original bill of lading and winery weight tag is REQUIRED for payment and Must be turned in everyday, (be brought to Rausser Bros Trucking, Inc 10359 Live Oak Ave Galt,CA or mailed PO Box 638 Galt, CA or Emailed to TAMMIRAUSSER@GMAIL.COM ) If paperwork is delayed, this will cause payment to be delayed as well.

**Dispatch:** Subhauler is required to have their own communication (cell phone). Subhauler will be asked to contact dispatch before they leave the field and after they are Unloaded at winery. **Returning empty trailers to designated field, is part of the load.** 

**Rate, Charges and Payment:** Payment by the broker will be made to the Subhauler Within 30 days after receipt of the carrier's freight bill has been received. Subhaulers are Responsible for cross checking their loads by keeping their gold rod freight bill copy, to Make sure they got paid for that load. If for any reason a load is missed, it will need to Be brought to Rausser Bros. Trucking, Inc. attention and it will be paid with in the week it Was turned in.

This agreement shall remain in full force and in effect until December 31, 2023 Or cancelled according to term of this agreement.
