### NOTICE TO STUDENTS. . . FOR IGNITE COURSE 6.0

OutFront Education is approved by the Georgia Real Estate Commission to offer sales prelicense, broker prelicense, postlicense and continuing education courses. The **school code is 6333** and the **renewal date is December 31, 2028**. The School Policies are located on our website at [OutFrontEducation.com](http://OutFrontEducation.com).

This program meets the requirement of the Georgia Real Estate Commission for a 25-hour GA Real Estate Sales Postlicense course or 33 hours of Continuing Education credit. When this course is completed for Postlicense credit, and completed before an agent's 1-year anniversary, 9 hours of Continuing Education credit will also be awarded in addition to meeting the 1<sup>st</sup> year Postlicense requirement.

In order to receive credit for this course you must:

**(Check Off and Read "Classroom" or "Virtual", or both if they apply, from the box below)**

- ☐ **Classroom:** Be **on time and present for the entire 36 hours of instruction**. Once the instructor begins each class you will not be allowed in the classroom. And, sign-in and sign-out on the daily attendance sheet.
- ☐ **Virtual:** Log into the class **on time and be present for the entire 36 hours of instruction**. **You must have the video feature of the Communication platform turned on at all times**. Your participation in this class is your consent to have your video screenshot collected strictly for attendance purposes. Student participation in this class is required, you must be at a stationary computer screen (no phones, except in the event of power outage) from your home or other neutral location. Anyone joining from a vehicle will not earn credit for attendance. Anyone joining while being compensated by an employer will not receive credit for attendance. Once the instructor begins you will not be allowed into the class session.

If you have taken this class in the past, **One Year and One Day** must have elapsed before you can take it again and receive CE credit.

Your completion information will be electronically transmitted to the Georgia Real Estate Commission via their Online course completion portal at the end of the course upon successful completion.

Entrance qualifications and standards of completion will not be based on a student's race, color, sex, religion, national origin, familial status or handicap.
