## Lifetime Rowing Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement ("Agreement")

IN CONSIDERATION of being given the opportunity to participate in any way in any Tampa Rowing Club ("Club") activities, including but not limited to the use of their facilities, boats, equipment and instructors (hereinafter "activity" or "activities"), I, for myself, my personal representatives, assigns, heirs, and next of kin:

- 1. ACKNOWLEDGE, agree, and represent that I understand the nature of rowing and related Activities, both on the water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity. \_\_\_\_\_\_ (initial)
- 2. FULLY UNDERSTAND that: (a) ROWING AND RELATED ACTIVITIES INVOLVE RISK AND DANGERS of serious bodily injury, including but not limited to permanent disability, paralysis, drowning, hypothermia, and death ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the Releasees named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ASSUME ALL SUCH RISKS AND ALL PERSONABLE RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity. \_\_\_\_\_\_ (initial)
