Pursuant to the aforementioned Emergency Order #12, if the public is unable to access the meeting by telephonic or video means set forth herein, the meeting will be adjourned and rescheduled.

**ARTICLE 1:** To choose in the manner provided by law, the following Village District officers:  
Commissioner – 3-year term  
Auditor – 1-year term

**ARTICLE 2:** To see if the Village District will vote to raise and appropriate the sum of \$1250 for general municipal operations. This article does not include special or individual articles addressed. (Majority Vote Required).

**ARTICLE 3:** To see if the Village District will vote to raise and appropriate the sum of eight hundred and fifty dollars (\$850) to be added to the Moeckel Pond Dam Reconstruction Capital Reserve Fund previously established. Recommended by the Board of Commissioners. (Majority vote required.)
