CONSIGNOR AGREEMENT

Therefore, the aforementioned Parties hereby agree as follows:

That For You Consignment agrees with Consignor to take the Consignor's goods on consignment to attempt to sell such goods for the Consignor, and

That in consideration of the above named and the following promises and other good and valuable consideration as in hereinafter recited, the parties further agree as follows:

1. Consigned items must be in excellent condition and of high quality. All apparel presented for consignment must be odor free, cleaned in the last three weeks and ready for resale. For You Consignment reserves the right to refuse items that are deemed to be unmarketable as determined by the sole discretion of For You Consignment for reasons including, but not limited to designer, style, size, condition, marketability, inventory levels and past selling experience.
2. The term of consignment shall be a period of sixty (60) days commencing the date the consigned goods are put on the sales floor by For You Consignment. All unsold goods become the sole property of For You Consignment after the sixty (60) day consignment period and shall be disposed of as For You Consignment sees fit.
3. For You Consignment determines the pricing of all consigned goods. The Consignor shall receive 35% of the final selling price, not including additional taxes paid, of any consigned goods. For You Consignment reserves the right to reduce the original advertised price of the consigned goods by up to 50% after thirty (30) days. Some consigned goods may be further reduced by up to 75% for the winter and summer clearance sales that For You Consignment may hold occasionally.
4. All consigned goods will remain in the possession of For You Consignment for the duration of the consignment period.
5. The Consignor may pick up payment for consigned goods that have been sold at any time during the normal business hours of For You Consignment
6. For You Consignment is not responsible for any fire, theft or water damage to any item. The Consignor agrees to waive any claim against For You Consignment for any losses or damage caused to any consigned good by theft, fire, water damage or any other natural disaster. For You Consignment shall take every reasonable precaution to assure that the Consignor's items are cared for in a safe and responsible manner during the consignment term.
