- 2. For You Consignment retains the discretion to reject items deemed unsuitable for sale, based on the subjective assessment of its staff. This evaluation may consider factors such as brand, style, size, condition, marketability, inventory levels, and past sales performance.
- 3. Consistently having more than 50% of submitted items declined may result in future rejection of consignments.
- 4. For You Consignment is responsible for determining the pricing of consigned items and will offer them for sale for a period of sixty (60) days.
- 5. The Consignor is entitled to receive 35% of the final sale price, excluding any applicable taxes, for each consigned item.
- 6. For You Consignment reserves the right to adjust the original listed price of consigned items at any point during the consignment period.
- 7. Consigned items will be held by For You Consignment for the entire duration of the consignment period, with proceeds securely stored in an account accessible to consignors during the establishment's normal operating hours.
- 8. Consignors will receive formal notification at the end of the consignment period (once all items have been sold or donated) regarding any outstanding balance. This balance will be retained for a period of one year following notification.
- 9. All correspondence with consignors will be conducted solely through email. It is the responsibility of the consignor to ensure that For You Consignment has access to a reliable email.
- 10. For You Consignment reserves the right to photograph any consigned item for informational purposes, such as providing details to potential customers via email or for sharing on social media platforms.
