

ADDITIONAL WAIVER-SERVICES FOR QUALIFYING INDIVIDUALS

HARP/HCBS

HARP-Health And Recovery Plan is a specialty
Medicaid insurance plan for qualifying
individuals. With Care Management under HARP,
you may also be eligible for a comprehensive
benefits package called Behavioral Health Home and Community Based Services (BH-HCBS).

These services are designed for individuals who would require the level of care provided in more restrictive environments such as a long-term care facility or psychiatric inpatient care if not for this aid.

SOME OF THE HCBS SERVICES:

- Psychosocial Rehabilitation (PSR)
- Community Psychiatric Support & Treatment (CPST)
- ▶ Habilitation Support
- Family Support and Training
- ▶ Peer Support Services
- Pre-vocational and Employment Services

WHAT'S INTEGRATED HEALTH?

Integrated Health is the latest initiative at Hamaspik of Rockland. As the name suggests, this program "integrates" services spanning the medical, behavioral and addiction fields.

Our goal is to ensure access to appropriate services, improve health outcomes, reduce preventable hospitalizations and emergency room visits, track and monitor patient outcomes, and avoid unnecessary care.

Expect an unprecedented care experience from a human services agency offering two decades of support for the OPWDD population.

Hamaspik of Rockland County is part of the New York State Hamaspik Association–a membership association comprising of 8 human services agencies providing services in 25 counties

Comfort Health is a sister-company to Integrated Health offering similar services to those under 21








DO I QUALIFY?

ELIGIBILITY CRITERIA:



Medicaid enrolled



Two qualifying chronic conditions (or one condition **AND** at risk of developing a second one). Examples: asthma, diabetes, heart disease, obesity, substance use disorder, mild behavioral health challenges.



OR one single qualifying chronic condition in the form of serious behavioral challenges (i.e. depression, anxiety, OCD, bipolar, psychosis, or personality disorders)
