**Terms of Contract:**

*The terms below describe the contract for storage between the above mentioned customer and Kennebec Boat and RV Storage, Inc.. By signing this contract, the above mentioned customer agrees to all contract terms.*

**Type of Storage and Season:**

**Deposit**

Customer agrees to pay a non-refundable deposit of **\$200** for this storage contract.

If customer changes their mind before drop off, there is no refund. However, the deposit may be applied toward future storage within one year.

**Payment**

Customer agrees to pay the balance of the total amount (less the **\$200** deposit) upon dropping off the vehicle for storage.

**Drop-offs:**

Kennebec Boat and RV Storage will contact customers the month prior to the start of contract season for scheduling a drop-off date and time.

**VERY IMPORTANT:** Once stored for the Winter season, **vehicles are not able to be taken out for any reason until unloading time.** This is to ensure the safety and security of all customers' vehicles and that nothing is being moved about during the winter.

**Pick-ups:**

Kennebec Boat and RV Storage will contact customers the month prior to the end of contract season for scheduling a drop-off date and time.

**Note: , Although our contractual responsibility is to be sure your vehicle is out of storage and in your care by the end of your last contracted month, we will always try to begin unloading winter vehicles during the last weekend of April, depending on weather conditions.**

**Insurance**

Insurance is NOT provided by Kennebec Boat and RV Storage:  
Please be sure your vehicle(s) are insured as we do not cover ANY physical damage or losses to your property while in our care, be it indoor or outdoor storage. This includes fire, theft, vandalism, water damage, etc...

**Security**

Due to our goal of keeping all customers' vehicles safe and secure, customers are not allowed on premises other than for pick-up, drop-off, or an agreed upon time with Kennebec Boat and RV Storage.

**Work or Maintenance**

Kennebec Boat and RV Storage will not maintain, repair, or work on any vehicles. Customers are not allowed to work on, or repair vehicles while they are in our care.

**Unclaimed Items**

If a customer's vehicle is not picked-up by the last day of the last contract month, their vehicle will be placed outside and customers will be charged \$25 per day until the vehicle is picked up. If not claimed by six months after the last day of the last contract month, the customer's vehicle may be moved to a different location and be sold off to pay all accrued penalties.
