## Pick-ups:

Kennebec Boat and RV Storage will contact customers the month prior to the end of contract season for scheduling a drop-off date and time.

Note: , <u>Although our contractual responsibility is to be sure your vehicle is out of</u> <u>storage and in your care by the end of your last contracted month,</u> we will always try to begin unloading winter vehicles during <u>the last weekend of April</u>, depending on weather conditions.

#### **Insurance**

Insurance is NOT provided by Kennebec Boat and RV Storage:

Please be sure your vehicle(s) are insured as we do not cover <u>ANY</u> physical damage or losses to your property while in our care, be it indoor or outdoor storage. This includes fire, theft, vandalism, water damage, etc...

### **Security**

Due to our goal of keeping all customers' vehicles safe and secure, customers are not allowed on premises other than for pick-up, drop-off, or an agreed upon time with Kennebec Boat and RV Storage.

#### **Work or Maintenance**

Kennebec Boat and RV Storage will not maintain, repair, or work on any vehicles. Customers are not allowed to work on, or repair vehicles while they are in our care.

#### **Unclaimed Items**

If a customer's vehicle is not picked-up by the last day of the last contract month, their vehicle will be placed outside and customers will be charged \$25 per day until the vehicle is picked up. If not claimed by six months after the last day of the last contract month, the customer's vehicle may be moved to a different location and be sold off to pay all accrued penalties.
