

JULY 2024 REGULAR MONTHLY MEETING

Chairman **Ledebuhr** called the July 3, 2024 Money Creek Town Board Meeting to order at 6:00PM. Other board members present included Supervisors **Feine** and **Hongerholt**, Clerk **Florin** and Treasurer **Deboer**.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Feine** motioned to approve the Secretary's Report as read. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** called for the reading of the Treasurer's Report. Treasurer **Deboer** reported aloud the following balances ending **June 30, 2024**:

Man has a lot in the subdivision in the village and he presented the supervisors with a plan to construct a new driveway. He went to Caledonia and the Zoning Administrator said he needed to talk to the Money Creek Board, he explained. He hasn't submitted a building permit application yet. Supervisors agreed to meet with the landowner this coming Saturday.

Corey Benson provided the Road & Bridge update – Dump Hill was a concern but it held together OK with the recent heavy rains. Christianson Hill Road was washed out, and River Drive had some damage as well.

Supervisor **Ledebuhr** talked to Rich Botcher about the truck and spraying plan, however Mr. Botcher hasn't submitted his employment paperwork yet.

Eric Worke by Haven Road complained about gravel not getting applied near his property, so Paul asked Bruening to deliver 2 additional loads there in the near future.

Supervisor **Ledebuhr** met with Syverson about the truck and showed him some details about the vehicle.

Supervisor **Ledebuhr** explained that Doug Rank is going to be busy with other issues this summer, so Paul asked the other supervisors what we should do with the truck. Supervisors discussed the options.

Supervisor **Ledebuhr** commented that the small rock shed is starting to get rotten near the bottom. Supervisors discussed options on what contractors would be available to repair this work.

The board discussed the details of the potential roadside spraying plan – Supervisor **Ledebuhr** presented a map showing the areas that needed attention. Discussion took place on ordering the chemicals and when we can start doing this work.

With no additional business to conduct, Supervisor **Hongerholt** motioned to adjourn the July 2024 Money Creek Town Board Meeting. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of adjournment. The meeting adjourned at 7:27 p.m.
