

## 2025 September Town Board Meeting Secretary's Report Sept. 4, 2025 – 6:00 p.m.

## **SEPTEMBER 2025 REGULAR MONTHLY MEETING**

Chairman **Ledebuhr** called the September 4, 2025 Money Creek Town Board Meeting to order at 6:00PM. Other board members present included Supervisor **Feine**, Treasurer **Deboer** and Clerk **Florin**. Supervisor **Hongerholt** attended via cellphone. The pledge of allegiance was recited.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Feine** motioned to approve the Secretary's Report. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** called for the reading of the Treasurer's Report. Treasurer **Deboer** reported aloud the following balances ending **August 31**, **2025**:

Supervisors reviewed zoning permit application #2025-Z-468068 from Lisa and James Kleist. Supervisor **Feine** motioned to approve the permit application. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisors reviewed zoning permit application #2025-Z-465949 from Mark Davidson on Larson Road. Supervisor **Feine** motioned to approve. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Mike Burbach mentioned that he got a phone call on Saturday regarding golf carts. He presented the boards with a highlighted printout of the Houston County Ordinance that was just recently passed to allow golf carts to register with Houston County and then be allowed to drive on any county road as long as the speed limit is 45 MPH or less. The permits are good for 3 years and there is no cost to the owners of the golf carts.

The tin has arrived for the town hall repairs; we are now waiting on Brandon Olson to start the repairs.

The plow truck is at Corey's to get cleaned up and prepped for sale.

Corey Benson provided the Road & Bridge Update. The roads are in decent shape, there are a few washboard and roads are getting hard. He has to fix a few intersections by pushing gravel around. Roadside spraying is completed and took effect pretty quickly. Discussed a few spots that trees needed to be taken care of perhaps this fall.

Supervisors discussed options for pre-buying propane for the town hall. Supervisor Feine motioned to pre-buy 800 gallons from Consolidated Energy for \$1.49/gallon. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.
