

**JANUARY 8 REGULAR MONTHLY MEETING**

Chairman **Ledebuhr** called the January 2026 Money Creek Town Board Meeting to order at 6:05PM. Other board members present included Supervisor **Feine**, Supervisor **Hongerholt**, Clerk **Florin**, and Treasurer **Deboer**. The pledge of allegiance was recited.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Hongerholt** motioned to approve the Secretary's Report. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Bruening delivered 10 loads of rock yesterday and today, Chairman **Ledebuhr** mentioned.

Chairman **Ledebuhr** hasn't talked to Johnny Micheel about the tree trimming yet.

VanGundy's is still working on Omodt Road.

Chairman **Ledebuhr** mentioned that the County has been seen updating the new E911 signs in the area.

Chairman **Ledebuhr** talked to Robin Danielson and Brian Forsyth today about the alley vacation and updated them on the status. The board is finishing up the final paperwork with Chiglo Law Office.

Supervisor **Hongerholt** motioned to set the 2026 Board of Audit as Thursday, February 5<sup>th</sup> following the regular February meeting. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

The supervisors reviewed the 2025 Road & Bridge certification from the Houston County Engineer's office. They discussed options to resolve the issues listed on that report.

With no additional business to conduct, Supervisor **Feine** motioned to adjourn the January 2026 Money Creek Town Board Meeting. This motion was seconded by Supervisor **Hongerholt**.
