

JUNE 2024 REGULAR MONTHLY MEETING

Chairman **Ledebuhr** called the June 6, 2024 town board meeting to order at 6:00PM. Other board members present included Supervisors **Feine** and **Hongerholt**, Clerk **Florin** and Treasurer **Deboer**.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk then read aloud. Supervisor **Hongerholt** motioned to approve the Secretary's Report as read. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** called for the reading of the Treasurer's Report. Treasurer **Deboer** reported aloud the following balances ending **April 30, 2024**:

Supervisor **Feine** then motioned to approve the Treasurer's Report as read. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Feine** made a motion to pay the bills. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Treasurer **Deboer** and Joan Redig are planning to work on a flower garden on the north side of the building.

Mr. Wally Wilkemeyer was in the audience and apologized to Corey Benson for an incident where he blew up at Corey after he mowed some flowers along the road in front of his house.

Corey Benson – spring mowing has been completed. Chairman **Ledebuhr** mentioned that the chloride will be applied next week.

Chairman **Ledebuhr** updated the board on the annual gravel application. A total of 3,148.93 ton has been applied on specific roads which will complete the seasonal application. This is well short of the expected 6,000 ton that the board had originally been expected, so this will save us around \$31,000.

Supervisor **Hongerholt** motioned to create a new separate fund for Sealcoating. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Hongerholt** motioned to transfer \$10,000 from the Road & Bridge Fund to the new Sealcoating fund. Motion seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** mentioned that the chloride will be applied by Houston County this year.

Supervisor **Hongerholt** motioned to adopt the resolution Appendix B to Authorize Contract with Interested Officer. Motion seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

The board reviewed the building permit from Tom VanGundy. Supervisor **Hongerholt** motioned to approve zoning permit application # 2024-Z-245197 for Thomas VanGundy. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Feine** motioned to hire Rich Botcher as our township road sprayer for \$26/hour. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Clerk **Florin** provided an update from emails to the board.

Chairman **Ledebuhr** explained that we need to bill Hart Township for the portion of the rock that we normally bill them for. Clerk will take care of this.

Chairman **Ledebuhr** requested that the clerk forward any building permits to his email from now on. Clerk Florin confirmed that he will forward them to all 3 supervisors from now on.

Clerk **Florin** downloaded CTAS 2024 and now the calculation is being included in the system and printed on the employees check stubs.

With no additional business to conduct, Supervisor **Hongerholt** motioned to adjourn the June 2024 Money Creek Town Board Meeting. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of adjournment. The meeting adjourned at 7:06p.m.
