

2025 June 5 Town Board Meeting Secretary's Report June 5, 2025 – 6:00 p.m.

JUNE 2025 REGULAR MONTHLY MEETING

Chairman **Ledebuhr** called the June 5, 2025 Money Creek Town Board Meeting to order at 6:00PM. Other board members present included Supervisors **Feine and Hongerholt,** Treasurer **Deboer** and Clerk **Florin**. The pledge of allegiance was recited.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Feine** motioned to approve the Secretary's Report as read. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman Ledebuhr called for the reading of the Treasurer's Report. Treasurer Deboer reported aloud the following balances ending May 31, 2025:

Supervisor **Feine** motioned to approve the Treasurer's Report as read. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Mike Burbach was on hand and presented the board with an annual renewal request for their liquor license for another year. Supervisor **Hongerholt** motioned to approve the application. Motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval. Mike also updated the board on the charitable gambling, the paperwork was messed up so it never happened.

Amy Hanson was concerned about vehicles and dump trucks coming around the corner from Highway 76 too fast, she is concerned and asked the board if they could do anything to help slow those down. The board responded that there wasn't much the board itself could do, however maybe talking to Brian Krage directly would help.

Joan Redig was on hand and asked about road rock; the supervisors mentioned they are starting today. Chairman **Ledebuhr** mentioned that he can give Joan's number to Mike Torgerson.

Chairman **Ledebuhr** provided the road update – Corey is out mowing. He pulled a sample from one of the trucks today. Supervisors discussed additional details of road rock application.

Chairman **Ledebuhr** talked to VanGundy's about Omodt Road – one point of discussion is the size of the turnaround. The board is still only pricing out the project; they have not yet decided whether to bring the road up to code yet.

The signs up on Deere Ridge Road are not up yet, Adam Heberlein told Chairman **Ledebuhr**.

Town Hall Damage update: Paul reached out to the agent again. The guy wanted an itemized bill, and the insurance company did not like how the bills were itemized. Chairman **Ledebuhr** is still working on this.

Chairman **Ledebuhr** attended the commissioners meeting on May 22nd. Apparently there was an issue with the recent Johnson building permit.

No chloride has been applied. Regarding the issue with dust on River Drive near Daniel Hirshberger, Chairman **Ledebuhr** mentioned that we are going to apply 300' of chloride near the site to help resolve the dust issue.

The board had made no progress on the issue with contacting the elected officials for Bets Reedy.

The old plow truck is fixed. Chairman **Ledebuhr** reached out to the MN action site about the old plow truck. One question is whether to put a reserve on it. The supervisors discussed an option to sell the old plow truck on FaceBook Marketplace. Paul suggested a price of \$15,000. Supervisors put off approving the sale of the plow truck until after the decals are pulled off.

Chairman **Ledebuhr** mentioned that RDO is coming to change the oil next week on the grader.

Corey Benson mentioned that the work done on the disc was great, it is working much better now.

Chairman **Ledebuhr** purchased a wi-fi lock for the town hall kitchen door. The one he purchased from Menards is a little more universal and should work out.

With no additional business to conduct, Supervisor **Hongerholt** motioned to adjourn the June 5, 2025 Money Creek Town Board Meeting. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of adjournment, and the meeting adjourned at 7:01pm.
