

**2025 November Town Board Meeting
Secretary's Report
Nov. 6, 2025 – 6:00 p.m.**

NOVEMBER 6 REGULAR MONTHLY MEETING

Chairman **Ledebuhr** called the November 6, 2025 Money Creek Town Board Meeting to order at 6:00PM. Other board members present included Supervisor **Feine**, Treasurer **Deboer** and Clerk **Florin**. Supervisor **Hongerholt** attended via cellphone. The pledge of allegiance was recited.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Feine** motioned to approve the Secretary's Report. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** called for the reading of the Treasurer's Report. Treasurer **Deboer** reported aloud the following balances ending **October 31, 2025**:

Supervisor **Feine** motioned to approve the Treasurer's Report as read. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Feine** made a motion to pay the bills. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Corey Benson provided the Road & Bridge report – there are washboards in a few spots, and we are hoping for some precipitation. He has been marking spots along the roads that might need some overburden. He discussed some of the issues with the Freightliner truck. Chairman **Ledebuhr** requested that Corey work on the washboards on some of the corners, especially Haven Road hill.

Chairman **Ledebuhr** talked to Chiglo about the alley vacation process, one of the zoning admins was on vacation for 3 weeks so that is causing a bit of a delay in closing this project out.

Chairman **Ledebuhr** spoke to Hoskins about the electrical work needed to repair the town hall building damage. He also talked to Brandon Olson of Canes Builders about some improvements on the rock shed, however this process is taking quite a long time. Supervisors discussed how many loads of ice rock they should order. Supervisor **Feine** made a motion to purchase 7 loads of ice rock. Motion seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** discussed the situation with Omodt Road. Lorie called him and said she wants full access all winter long. VanGundy's thought is to raise the road up, add 2-18" culverts, some rip-rap on the upper side and lower side. Since it is all sugar sand, raising the road a foot or so is the best way to accomplish that. The estimate VanGundy's provided is \$19,422, which does not include the turnaround. Supervisors discussed options and whether or not she would include a turnaround on her property. Supervisor **Feine** motioned to approve the quote. Supervisor **Hongerholt** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Bruening hasn't hauled any overburden in yet; Paul isn't sure if they are still going to do this yet this season.

Supervisors discussed setting a budget for tree cutting again this winter. Paul has a list of a few spots that need attention. Supervisor **Feine** motioned to set a maximum of \$15,000 for this winter season tree cutting. Supervisor **Hongerholt** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

With no additional business to conduct, Supervisor **Feine** motioned to adjourn the November 2025 Money Creek Town Board Meeting. This motion was seconded by Supervisor **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of adjournment, and the meeting adjourned at 7:05pm.
