

## 2024 December Town Board Meeting Secretary's Report December 5, 2024 – 6:00 p.m.

#### **DECEMBER 2024 REGULAR MONTHLY MEETING**

Chairman **Ledebuhr** called the December 5, 2024 Money Creek Town Board Meeting to order at 6:00PM. Other board members present included Supervisors **Feine and Hongerholt**, Treasurer **Deboer** and Clerk **Florin**. The pledge of allegiance was recited.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Hongerholt** motioned to approve the Secretary's Report as read. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman Ledebuhr called for the reading of the Treasurer's Report. Treasurer Deboer reported aloud the following balances ending November 30, 2024:

Supervisor **Feine** motioned to approve the Treasurer's Report as read. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Feine** made a motion to pay the bills. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Corey Benson provided a road report; he was able to do some work on River Drive. Paradise, Doblar, Stinson, and a few other roads had been cut or double cut. The roads are frozen now so no more grading will take place. Doug spent some time in the new truck and is ready for snowplowing. Chairman **Ledebuhr** and Doug spent Sunday getting ready for snowplowing. Chairman **Ledebuhr** mentioned that he talked to Jim Quinn about making a fuel delivery soon.

Chairman **Ledebuhr** talked to Perry Benson, who previously indicated that he does not want to salt the roads this season – he just wanted to plow snow. After talking to Chairman **Ledebuhr**, Mr. Benson offered to plow and salt for \$150/hour rather than the \$130/hour rate he previously quoted. He will activate his contractor's insurance once there is significant snow in the forecast. Supervisor **Hongerholt** motioned to approve this quote to have Perry Benson plow and salt the seal-coated roads for \$150 per hour. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

The only quote we received for trimming the village roads and the ridge was from Johnny Micheel of Chimney Rock Forestry. They quoted \$6,600; Chairman **Ledebuhr** was waiting for another quote but he hadn't received it yet. After further discussion, Supervisor **Hongerholt** motioned to approve the quote from Chimney Rock Forestry for \$6,600 to trim trees around the village. This motion was seconded by Supervisor **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** received an email from Laurie Omodt on Friday November 14, which he read to the board. The board discussed options on how to resolve the issue; the board expressed the importance of having the people present in person at the board meetings to discuss the options. One of the main issues, Paul and Randy explained, are the water breaks. Chairman **Ledebuhr** will call the Soil & Water department to see what they think.

Following up from the an issue decided upon at the prior meeting, the yield sign was removed from Breezy Drive and was moved to County Line Drive / Ronnenberg Road intersection. Adam Heberlein also took care of some other sign issues in the area and added the STOP sign to the top of Gates Coulee Drive.
