

**2025 December Town Board Meeting
Secretary's Report

DECEMBER 4 REGULAR MONTHLY MEETING

Chairman **Ledebuhr** called the December 2025 Money Creek Town Board Meeting to order at 6:00PM. Other board members present included Supervisor **Feine**, Supervisor **Hongerholt**, and Clerk **Florin**. Treasurer **Deboer** was absent. The pledge of allegiance was recited.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Hongerholt** motioned to approve the Secretary's Report. This motion was seconded by Chairman **Feine**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** called for the reading of the Treasurer's Report. Clerk **Florin** provided the grand total value only due to the treasurer being on vacation:

Doug Rank was present and updated the board on the status of the snowplowing recently completed. There are a few snow-packed areas on the roads. Consolidated brought fuel recently. Adam is still working on the truck – there is an issue with the throttle position sensor. Replacing one is fairly expensive.

Chairman **Ledebuhr** updated the status of Omodt Road – VanGundy's has started, and Perry Benson will do the snow plowing for the entire road. Lori mentioned to Paul that she was very happy with the results. VanGundy's is going to wait until the ground freezes to do the rest of the rock. Bruening's delivered ice rock to the shed. Chairman **Ledebuhr** talked to Johnny Micheel about tree trimming, and he is going to meet with Johnny on the details soon.

Chairman **Ledebuhr** contacted Ness and they have removed the portable outdoor toilet for the season.

Franklin Drive needs to be salted, it is glazed and icy on the little hill section.

Chairman **Ledebuhr** talked to Chiglo Law Office about the alley vacation – he was going to send the final paperwork to Clerk **Florin**, however the Clerk hasn't received it yet. The Clerk and Chairman have to sign the final order, then return the signed paperwork to Chiglo to have it recorded at the county. The Clerk reminded the supervisors that we also need to send invoices to the landowners once this project is fully completed.

With no additional business to conduct, Supervisor **Feine** motioned to adjourn the December 2025 Money Creek Town Board Meeting. This motion was seconded by Supervisor **Hongerholt**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of adjournment, and the meeting adjourned at 6:50pm.
