

OCTOBER 2025 REGULAR MONTHLY MEETING

Chairman **Ledebuhr** called the October 2, 2025 Money Creek Town Board Meeting to order at 6:00PM. Other board members present included Supervisor **Feine**, Treasurer **Deboer** and Clerk **Florin**. Supervisor **Hongerholt** attended via cellphone. The pledge of allegiance was recited.

Chairman **Ledebuhr** called for the reading of the Secretary's Report, which the Clerk read aloud. Supervisor **Feine** motioned to approve the Secretary's Report. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** called for the reading of the Treasurer's Report. Treasurer **Deboer** reported aloud the following balances ending **September 30, 2025**:

Supervisor **Feine** motioned to approve the Treasurer's Report as read. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Feine** made a motion to pay the bills. This motion was seconded by Chairman **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Chairman **Ledebuhr** mentioned that the township attorney still has not sent the board the final alley vacation paperwork, and Paul mentioned that he would get with Chiglo asap to find out the status.

Treasurer **DeBoer** was checking to find out whether a climbing wall could or should be added to the playground. She will be working to get more information. She explained that we needed to check with our insurance company to find out if there are any limitations on the height of the climbing wall.

Corey Benson provided the R&B report – he has been grading a lot lately with the recent rains. He has been working hard on the old plow truck, to clean it up and paint it. He explained some of the parts that were being replaced. Chairman **Ledebuhr** requested that the clerk request a new title from the MN DVS.

Steve Hartwick was on hand regarding the silica sand mine in Yucatan township – apparently the landowners had requested that the county board amend the county ordinance to remove a specific limitation of land between sand mines. Steve explained that when the county is amending the Houston County Ordinance, the County is obligated to notify all Houston County residents to notify them of the amendment. Apparently the county board published information in the Caledonia Argus; Steve's concern is that the county board isn't following the MN statutes governing public hearings and notices when the county ordinance is being amended. He will be visiting other town boards in the county also to find out if they had received notice of the ordinance being amended. Supervisor **Feine** motioned to have the clerk email Amelia Meiners requesting information about the sand mine. Chairman **Ledebuhr** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

The board reviewed the Rushford Fire Contract renewal paperwork from the City of Rushford. Supervisor **Feine** motioned to approve the Rushford Fire Contract. Chairman **Ledebuhr** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Feine** motioned to approve the 2025 Road Mileage Certification for Houston County DOT. Chairman **Ledebuhr** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Supervisor **Feine** motioned to approve building permit 2025-Z-466417 for Keith Voegel. Chairman **Ledebuhr** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

The board reviewed a request from Joel Luhmann regarding a field driveway on Dump Hill Road, and asked if the town board would have any issues with it. Supervisor Feine motioned to approve the request. Chairman **Ledebuhr** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

We received a Thank You from Joan Redig for the flowers for Wayne Purtzer's celebration of life.

Lori Omodt-Tebreak reached out to Chairman **Ledebuhr** regarding the status of Omodt Road. Paul asked VanGundy's to quote the work but they haven't responded yet. The board discussed simply shaving down the burms this year and then working on it more next year. Supervisor Feine motioned to have VanGundy's perform no more than \$3,000 maintenance on Omodt Road. Chairman **Ledebuhr** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

Bruening reached out to Paul about hauling overburden. The board discussed putting a maximum dollar limit on hauling the material. Supervisor **Feine** motioned to spend up to \$25,000 to hauling and setting the overburden to a handful of our township roads that need it. Chairman **Ledebuhr** seconded the motion. Chairman **Ledebuhr** called for a vote which was unanimous in favor of approval.

MiEnergy reached out to Paul Ledebuhr – they are going to need to bore under Stinson Road and also Doblal Road before winter to run electrical lines.

The building damage is fixed, however Hoskins still needs to do some electrical work to get the A/C working, and also needs to do some conduit work.

With no additional business to conduct, Supervisor **Feine** motioned to adjourn the October 2025 Money Creek Town Board Meeting. This motion was seconded by Supervisor **Ledebuhr**. Chairman **Ledebuhr** called for a vote which was unanimous in favor of adjournment, and the meeting adjourned at 7:31pm.
