

1 Year Limited Warranty

Granite and Quartz Countertops

1 Year Limited Warranty

WC Granite warrants to the original end user-purchaser/owner that its products shall be free from manufacturing defects under normal use and service. This warranty applies to the repair, or replacement, of failed product that has been permanently installed in the original owner(s) residence. This includes reasonable labor charges needed to repair or replace the product. Such obligation as to repair or replacement, shall further be limited to repair, or replacement, with colors, styles, and finishes of products that are available at the time of repair, or replacement. The option to repair, or replace, or to refund the purchase price of the countertop to the original owner, due to product failures or manufacturing defects, is at the sole discretion of WC Granite.

The 1 Year Limited Warranty is non-transferrable and applies to countertop and sink products only for interior, residential use. The warranty does not cover seam performance or appearance. This warranty is void unless the product has been paid for in full.

Under this 1 Year Limited Warranty, WC Granite must be permitted sufficient time and opportunity to inspect the product(s), evaluate and respond to any claim(s). All decisions regarding the existence of product failures or manufacturing defects, affecting this warranty, shall be made by WC Granite and shall be final and binding upon all parties.

Exclusions for the 1 Year Limited Warranty

- 1. Use for any exterior application or for any flooring application.
- 2. Damage caused by improper use includes, but is not limited to, damage from accidents, abuse of impact, chemical damage, corrosion damage, acts of nature, job-site conditions, or structural movement.
- 3. Damage from excessive heat, scorching or exposure to weather conditions, exposure to ultraviolet light.
- 4. Damage such as chipping, cracking, or impact damage or breaking due to customer use.
- 5. Damage due to cleaning with abrasive products, acid, bleach, ammonia, vinegar, lemon juice or cleaners that contain these chemicals.

- 6. Damage caused by cosmetic stains, tar, hair oil or skin oil.
- 7. Damage caused by accelerants, cyanoacrylate glues, dyes, resin infused plumber's putty, material defects or color fading.
- 8. Damage due to ink, paint, or magic marker stain.
- 9. Stains due to mold, mildew, algae, fungus, rust, iron, bronze, copper, or other metals.
- 10. Damage due to exposure to excessive heat that creates white marks, white rings or cracks that appear on the product.
- 11. Damage due to countertops that have been removed from the original place of installation.
- 12. Seam performance, seam appearance, adhesives, caulk and/or other accessory items.
- 13. Damage caused by improperly installed appliances.
- 14. Conditions caused by normal ware and tear such as stains, scratches, water spots and burns. Products are not scratch, heat or stain proof.
- 15. Damages due to improper care and maintenance.
- 16. Damage caused by mishandling or misuse.
- 17. Variation in color, shape, shade, pattern, and size are traits of natural stone and quartz countertops.
- 18. Supplemental repair including, but not limited to, electrical, tile or wall surfaces, backsplashes, cabinetry, and plumbing modifications necessary to repair the countertop.
- 19. Defects that were visible at the time of fabrication/installation but were not reported during fabrication/installation.
- 20. Cracks caused by "dry" cutting, polishing, unevenness, or improper edge details.
