## **TERMS AND CONDITIONS**

This Agreement, entered between Cougar Creek Outfitters (hereinafter “CCO”) and the undersigned hunter (hereafter “Hunter”) sets out all aspects of the complete agreement between the parties and reflects the final agreement concerning the hunt specified above (hereinafter “Hunt”).

### **1. THE COST OF THE HUNT INCLUDES**

- a. Licensed Guides in the State of Nevada;
- b. Transportation while in the field
- c. Fuel
- d. Caping/skinning;
- e. Packing wildlife to Hunter’s mode of transportation from camp;
- f. Trophy Fees

### **2. THE COST OF THE HUNT EXCLUDES**

- a. Lodging before and after the Hunt;
- b. Transportation to and from location;
- c. Taxidermy;
- d. Meat processing and shipping.

3. Hunter acknowledges that the deposit and the remaining balance due are non-refundable, once paid. Hunter is not entitled to a refund or prorating if the Hunt is stopped due to inclement weather or any other reason beyond the control of CCO or if the Hunter is asked to leave prior to the expiration of the Hunt.
4. CCO and Hunter shall obey all Nevada and Federal Hunting Laws, Rules, and Regulations.
5. The Hunt is a fair-chase hunt. As such, CCO and this Agreement do not guarantee or promise Hunter a kill or a shooting opportunity.



6. Hunter acknowledges that he/she may be guided by a licensed sub-guide rather than the Master Guide.
7. CCO assumes that Hunter is comfortable and familiar with hunting and outdoor recreation activities and has sufficient hunting skills and abilities for the type of hunt booked.
8. Hunter shall have intimate knowledge of the safe operation of the weapon being used and practice firearm safety.
9. It is the responsibility of Hunter to ensure that his/her physical condition is satisfactory for the hunt. All physical limitations or health problems must be made known to CCO in writing as well as verbally to your guide. Hunter assumes all responsibility for such conditions and holds CCO harmless thereto as described in the RELEASE OF LIABILITY & ASSUMPTION OF RISK. CCO shall accommodate Hunter's physical limitations and/or disabilities to the best of its ability. Hunter acknowledges that due to the steep terrain in the State of Nevada that all accommodations may not be feasible.
10. Hunter hereby agrees to accept and respect CCO's judgement concerning safety at all times.
11. CCO reserves the right to stop the hunt at any time due to reasons such as, but not limited to, the Hunter's safety or natural occurrences, such as weather.
12. Hunting success and activities depend greatly on weather, game conditions, skill, and physical conditions of the Hunter. CCO may, at its sole discretion, change the camp location or make other changes to best increase the opportunity to make the Hunt successful.
13. If Hunter is unwilling to abide by all of the terms of this Agreement, then CCO may, at its sole discretion, ask Hunter to leave and cancel the Hunt with no refund.
14. CCO is licensed and required to possess liability insurance and acknowledges that its activities are regulated by the laws of the State of Nevada.
