**RELEASE OF LIABILITY & ASSUMPTION OF RISK**

In consideration of being permitted to hunt with Cougar Creek Outfitters:

I, \_\_\_\_\_, the undersigned, acknowledge and understand that hunting, hiking, and wilderness travel (hereinafter collectively referred to as "Activities") are dangerous activities that involve inherent known and unanticipated risks that may result in serious injury, death, or property damage. I agree to assume full responsibility for all risks of loss, damage, and injury or death that I may sustain while engaging in the Activities.

I hereby for myself, my heirs, administrators, personal representatives, assigns, and estates, forever RELEASE AND DISCHARGE Cougar Creek Outfitters, its owners, employees, sub-guides, agents, and their insurers (hereinafter collectively referred to as the "Released Parties") from any and all losses, liabilities, claims, demands, causes of action and costs (including attorney's fees) that I may hereafter have for death, injuries, and property damage arising out of or related to my participation in the Activities, whether caused by the negligence of the Released Parties or otherwise.

I further agree that I WILL NOT SUE OR MAKE CLAIM AND WAIVE THE RIGHT TO DO SO against the Released Parties for losses, liabilities, damages and costs (including attorney's fees) arising out of or related to my participation in the Activities, whether caused by the negligence of the Released Parties or otherwise. I hereby instruct my heirs, administrators, personal representatives, assigns, and estates never to institute and sue or action at law or otherwise against the Released Parties, nor to initiate or assist the prosecution or any claim or cause of action that I, my heirs, administrators, personal representatives, assigns, and estates may have by reason of my death, injuries, or property damage arising out of or related to the Activities, whether caused by the negligence of the Released Parties or otherwise.

I further agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from any and all losses, liabilities, claims, judgements, and costs (including attorney's fees) incurred

in connection with any action brought as a result of my participation in the Activities, whether caused by the negligence of the Released Parties or otherwise.

I further agree to IDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from any and all losses, liabilities, claims, demands, judgments, and cost's (including attorney's fees) for death, injury, or property damage I may negligently or intentionally cause while participating in the Activities.

I understand that injuries received may be compounded or increased by negligent rescue operations or procedures of the Released Parties. I further agree that this Agreement extends to all acts of negligence by the Released Parties, including negligent rescue operations and procedures. I understand that this Agreement is intended to be the final, complete, and exclusive statement of the terms hereof notwithstanding any representations, statements, or agreements to the contrary heretofore made. I further recognize and agree that any modification of this agreement shall be binding only if evidenced in a writing signed by Cougar Creek Outfitters.

I acknowledge that this Agreement and any rights, duties, and obligations as between the parties to this Agreement shall be governed solely in accordance with the laws of the State of Nevada in which these events occur.

I HAVE CAREFULLY READ, AND I UNDERSTAND, ACKNOWLEDGE AND AGREE TO THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK. I UNDERSTAND THAT I AM GIVING UP VALUABLE LEGAL RIGHTS BY SIGNING THIS AGREEMENT, AND THAT THIS AGREEMENT REPRESENTS A CONTRACT BETWEEN COUGAR CREEK OUTFITTERS AND MYSELF. I HAVE VOLUNTARILY CHOSEN THE ACTIVITIES IN WHICH I AM PARTICIPATING.
