
Belpre is a city located in <u>Washington County Ohio</u>. With a 2020 population of 6,382, it is the 222nd <u>largest city in Ohio</u> and the 4171st <u>largest city in the United States</u>. Belpre is currently declining at a rate of -0.03% annually and its population has decreased by -0.92% since the most recent census, which recorded a population of 6,441 in 2010. Spanning over 4 miles, Belpre has a population density of 1,831 people per square mile.

- Black or African American: 2.13%





# **Church History**

Mullen Memorial Baptist Church is located atop a hill overlooking one of the main intersections in town at Putnam Howe Drive and Washington Boulevard. The church sits between a senior citizens apartment complex and the city building. The location offers easy access and visibility to the community.

The history of Mullen Memorial Baptist Church began with a Sunday school class that met on Sunday afternoons.

In the early 1900's three sisters, Abbie (Mullen) Druce, Nora (Mullen) Goodno, and Emma Mullen, all who lived in Belpre, crossed the Ohio River to attend the First Baptist Church of Parkersburg. Later in the afternoon, Nora would lead a Sunday school class in her home.



As the population in Belpre grew, so did the Sunday school class. It was not long before the class began to meet in the schoolhouse across the road from Nora's home. When the schoolhouse was no longer used for education, the Mullen sisters purchased the schoolhouse, and the property surrounding the school.



The schoolhouse still stands today, and is used for the Boy Scout Troop which is Church Sponsored. The schoolhouse still stands today, and is used for the Boy Scout troop #91.

## Pastor and the Officers

#### PASTOR:

The Pastor shall discharge the duties and responsibilities enjoined upon him by the Scriptures as a bishop or elder of the local assembly. He shall fulfill in his personal and ministerial life the qualifications of such as set forth in I Timothy 3:1-7; II Timothy 4:2; and Titus 1:5-9.

He shall preach the Word, conduct regular services, administer the Ordinances, tenderly watch over the membership and spiritual interest of the church, and organize and develop the church for the best possible service. He shall confer with the Moderator in setting the Agenda to carry out the business of the church. He shall, in cooperation with the Board of Deacons, prepare a written report of the spiritual life and work of the church during the past year to be presented at the Annual Meeting.

The Pastor shall be given sufficient personnel and equipment to conduct the work of his office in an orderly and efficient manner. As spiritual head of the church, he shall not be burdened with responsibilities that might detract from the Great Calling. The pastor shall be an ex-officio member of all boards and committees. He shall have utmost freedom in advising the various boards and committees of the church but shall not be responsible for their action. He shall have the undivided and wholehearted support of the church in his ministry.

<u>DEACONS</u>: Deacons will be ordained according to Acts 6:5-8. The qualifications of a deacon are set forth in I Timothy 3:8-13.

The active Board of Deacons, with the pastor, will review and recommend those men who possess the necessary qualifications of a deacon. Those recommended will then be presented to the church at a regular Business Meeting for election as deacons. The voting will be by written ballot.

The board consists of nine (9) members, previously elected by the church. Three (3) members are elected each year by vote of the church for a term of three (3) years. One third of the board will rotate each year. There is a mandatory one year out of office before being eligible to serve another term. If a vacancy should occur, it will be filled by another eligible deacon upon vote of the church. The voting will be by ballot.

Duties of active Deacon Board Members include the following:

They shall assist the pastor in developing the spiritual life of the church, meeting regularly with him for prayer, consultation, and program planning. They shall cooperate with the pastor in visiting the membership and in caring for the sick, needy, and distressed members. They shall oversee the disbursement of the Deacon Fund and prepare for observance of the Ordinances of the church.

The deacons, with the pastor, shall compose the Membership Committee and shall interview all candidates for baptism and membership. They will continually review the Membership Roll and, at a scheduled Business Meeting, shall present their recommendations for changes to the roll. <u>TRUSTEES</u>: Two trustees shall be elected at the December Business Meeting to serve the term of three years.

The trustees shall have the care and custody of all church properties. They shall be responsible for all necessary repairs, administering the funds provided by the church to maintain the properties, disbursing the same as the church shall direct. The trustees shall maintain the building in good order and provide for all preparations for services of the church.

The Board of Trustees, with the pastor, may recommend to the Nominating Committee those persons willing to serve as Trustees.

<u>ADVISORY BOARD</u>: The Advisory Board shall consist of the Pastor, all church officers and chairpersons or presidents of all boards and committees and auxiliary organizations. Any interested member of the church is welcome to attend the Advisory Board meetings. The duties of the Advisory Board will be to coordinate the activities of the church and provide advisory oversight.

<u>BOARD OF CHRISTIAN EDUCATION</u>: The Board of Christian Education shall consist of six members. Two members shall be elected at the December Business Meeting to serve the term of three (3) years. There shall be a Chairman and/or Co-Chairmen of the Board and a Chairman of Missions elected annually from within the Board.

The Sunday School Superintendent or the Assistant Sunday School Superintendent shall be an exofficio member of the Board.

The Board, working with the Sunday School Superintendent or the Assistant Sunday School Superintendent, shall plan and carry out the entire educational program of the church, including the work with children, youth, adults; missionary and stewardship supervision and education; leadership training; summer camps, and Daily Vacation Bible School.

All literature used in the Education, Study, or Devotion Program of the church for children, youth, or adults must be brought to the Board for approval. If a new class or group of any kind is to be formed, suggested teachers and proposed literature must be presented to the Board by the Sunday School Superintendent or the Assistant Sunday School Superintendent for approval.

All approved literature shall be ordered by the Sunday School Superintendent or his/her appointee.

Board of Christian Education 2021

The BOCE is responsible for several areas of instruction within the church.

The main function of this organization within the church has been dealing with the Sunday School classes and various activities for the youth. In the past, we have had more than one adult Sunday school class, and we have had various configurations of classes from nursery to post high school and career classes. The Sunday school classes have mainly been conducted with quarterly literature, but in recent years we have used church-wide programs, introducing topics for study in Sunday school and reinforcing these topics in the sermons. This unifying model helped a lot during Covid, allowing study to continue individually, and reinforcing these studies with online sermons and parking lot church, broadcast over radio frequency. The BOCE has tried to encourage the youth of our church, during these times, of not meeting face-to-face by taking surprise goody bags periodically to the children at their homes. We want to let them know we are still here for them and look forward to seeing them at church in the future.

Until 2020, MMBC held Vacation Bible School every summer for area youth, almost since the church began in 1923. Some of the themes in more recent years have been, "Jesus Helps You Power UP," The Jungle Adventure," and Hometown Heroes." Usually the church began VBS with a Kick-off on Sunday evening and ended with a program and picnic. Due to Covid, we have not held VBS for the last two years.

In order to provide outreach to the Belpre community and beyond, the BOCE has sponsored several activities at the church for families that were well advertised throughout the community including flyers to area schools. These activities included: Winter Carnival in January, Egg hunt near Easter, and our Fall Festival that included a meal and Trunk or Treat for the children. (More details on these events can be found under Ministry Events- Guide Book.)

The church also participated in the community program, "The Gathering," held at Civitan Park in September. All of these activities have been postponed for the last two years.

We have recently renewed our "Come to the Table," program on September 12, 2021. These gettogethers occur on Sunday evenings with a devotion, a meal and a group activity in which the tables compete or just participate. The BOCE also hopes to be able to have the Fall Festival and the annual Christmas movie night PJ party and participation in the Light Parade.

We just finished collecting bacterial wipes, tissues and paper towels for Belpre Elementary School.

In the future, we hope to add a new Junior Youth program and see some of our past programs be reinstated as the virus diminishes. We pray for health for our children and adults as we strive to do God's will.

<u>ASSISTANT SUNDAY SCHOOL SUPERINTENDENT</u>: The Assistant Sunday School Superintendent shall aid the Superintendent in the management of the Sunday School and take charge in the absence of the Superintendent.

<u>SUNDAY SCHOOL SECRETARY</u>: The Sunday School Secretary shall present an accurate record of each Sunday School Class, together with the total combined attendance every Lord's Day. An Annual Report of Sunday School activities must be prepared for the Annual Business Meeting.

In the absence of the Sunday School Secretary, the Assistant shall fill the vacancy.

<u>CRADLE ROLL DIRECTOR</u>: The Cradle Roll Director is responsible for calling on and enrolling new babies in the church family.

<u>CHURCH CLERK:</u> The church Clerk shall keep a correct record of the proceedings of the church at all Business Meetings, retain a complete registry of the membership, issue letters of dismission and recommendation as directed by the church, conduct its official correspondence, preserve all documents, papers and letters received during the term of office. The Clerk shall deliver the same and all records kept to the successor.

In the absence of the Church Clerk, the Assistant Church Clerk shall fill the vacancy.

<u>TREASURER</u>: The Treasurer shall receive a record of all funds contributed and disburse the same as directed by the church. The Treasurer shall make a Monthly and Annual report of receipts and disbursements, showing the actual financial condition of the church and shall be ready to show the records at all times upon request.

In the absence of the Treasurer, the Assistant Treasurer shall fill the vacancy.

<u>FINANCIAL SECRETARY</u>: The Financial Secretary shall receive and record all money contributed to the church and shall be ready at all times to show the records. The record book must correspond with the Treasurer's books at all times. All money shall be deposited to the church account on the next banking day after it is received and recorded.

A balanced account of all funds shall be presented to the church at the Annual Meeting.

The Assistant Financial Secretary shall fill this office in the absence of the Financial Secretary.

<u>SUNDAY SCHOOL SUPERINTENDENT:</u> The Sunday School Superintendent shall direct the sessions of the school and, in every way possible, endeavor to build up the attendance and interest of the church in the study of the Word. The Superintendent shall, at all times, strive to work in cooperation with the Pastor to effect the conversion and spiritual development of those attending Sunday School.

The Superintendent shall call and conduct meetings when necessary for the purpose of outlining the program of the school and directing the same with the Pastor and the Chairman of Christian Education.

<u>MUSIC DIRECTOR</u>: The Music Director shall cooperate with the Pastor and Deacons in the preparation of all music for the church. The Assistant Music Director shall fill the office in case of a vacancy.

#### The Music Department

For every person there is a favorite way to worship and praise the Lord in song. It could be with praise bands, traditional organ and piano, through a choir or in small groups, or just raising your voice in song, you just need to find what is right for you. At Mullen Memorial Baptist Church we have a blended service of music using today's contemporary songs to the classic hymns of all times, we even have a little southern gospel at times. If you love the Lord and love to worship we welcome you to join us. We have a chancel choir that sings during our morning worship each week. We also enjoy celebrating the holiday season with Special Music and Cantata's We have a Praise Team that leads singing and helps to bring the more contemporary music to our worship. ## WHAT WE BELIEVE

### OUR FAITH IS SHAPED BY THE WORD OF GOD AND THE EXAMPLE OF JESUS CHRIST

<u>THE SCRIPTURES</u>: We believe that "all" scripture is given by inspiration of God by which we understand the whole Bible to be verbally inspired by the Spirit of God to Holy men of old.

We believe, also, that our redemption has been accomplished solely by the blood of our Lord Jesus Christ and that no repentance, no feeling, no faith, no good resolutions, no sincere efforts, no submission to the rules of any church, can add in the very least degree to the value of the blood or to the merit of the finished work wrought for us by our Lord Jesus Christ.

<u>THE CHURCH, A UNITY OF BELIEVERS</u>: We believe that all who are united to the risen and ascended Son of God are members of the Church which is the Body and Bride of Christ regardless of membership or non-membership in the organized churches of earth. We believe all Christians are under the solemn duty to keep the unity of the Spirit in the bond of peace, rising above all sectarian differences, and fervently loving one another with a pure heart.

Resolution on Human Sexuality

Adopted by MMBC July 15, 2015



Because we are all wounded and broken people in need of the healing power of God's grace in Christ Jesus, and being aware of the confusion of voices pertaining to human sexuality, the following statement defines our common understanding for sexual behavior.

We affirm the Bible as our rule for faith and practice and embrace its ethic of compassion, love, and ministry to all persons and the availability of God's grace through repentance. (Luke 5:30-32; John 8:1-11; 1 Corinthians 6:11).

We affirm that God's gracious intention in creation for human sexual conduct as defined in scripture is faithful, lifelong heterosexual union for married persons and committed celibate behavior for unmarried persons. Other sexual practices clearly defined as sinful in Scripture are destructive of individuals, of community, and of the fellowship of believers, and like all sin, call for repentance, openness to the transforming power of God, and restoration to the community of faith. (Genesis 1:27, 2:24; 1 Thessalonians 4:3-8; Hebrews 13:4); (Leviticus 18:22, 20:13; Romans 1:18-32; 1 Corinthians 6:9-10).

We abhor and reject violence of all kinds against persons of all sexual orientations.

Therefore, we resolve that this Region will encourage grace-motivated ministries which respond to human need and offer God's transforming love to all wounded and broken people, including heterosexual, homosexual, bisexual, and transgendered persons.

Acknowledging the high calling of church and Region leadership, we resolve that this Region will not recognize for ordination or recognize the preexisting license or ordination of any person practicing, affirming, endorsing, and/or celebrating adultery, fornication, gay/lesbian/bisexual behavior.

And finally, because of our commitment to do mission together under the authority of the Word of God; we resolve that the professional staff of the American Baptist Churches of Ohio will counsel appropriate action consistent with this resolution to the association\* of any church within this Region that endorses, celebrates, or affirms adultery, fornication, gay/lesbian/bisexual behavior.

- Pursuant Bylaws of ABC/Ohio, Rule 3:
- Constituency, Rule 3.2.2

"A church shall be dismissed from the Region, and thus from the denomination, by recommendation of the association of which it is a member. Each association shall implement its own criteria for dismissal of member churches with counsel from the Region's professional staff and with reference to ABC/USA's 'Common Criteria for a Cooperating Church'".
