Applications are open and will be reviewed on a rolling basis starting on October 15.

Please note that some categories do fill up for each market. The earlier you apply, the more likely you are to get your preferred date, if accepted.

Please review all of the following information carefully BEFORE you complete the application.

By submitting your application, you are agreeing to these guidelines.

Concord Arts Market is juried for each event. Application is not a guarantee of participation. First consideration will be given to past and regular participants of the Concord Arts Market, as well as vendors with unique products. The jury reserves the right to update participating vendors at its discretion to keep the mix of goods both balanced and diverse.

VENDOR SPACE: Vendor spaces vary per location. In most cases, vendors will have at minimum enough space for a 6-8ft table and room behind for a chair. If you have questions or concerns about your space, please contact us.

Two accepted artists may share a space. Single artists will not be allowed two spaces.

Vendors are responsible to provide their own tables, chairs and displays. Outside vendors must provide their own tent with ample weights (see our tent policy at the end).

EARLY DEPARTURE: Early departure from any market is NOT allowed. If an emergency arises and you need to leave early, please notify market staff immediately so that arrangements can be made. The success of the market depends on the commitment of the participating artists. Additionally, the liability issues created by moving vehicles and displays while the venue is open to the public create a hazard to the event.

WEATHER POLICY: Concord Arts Market events are *rain or shine*, and vendors are still expected to attend in the event of inclement weather. Vendors who no-show to an event due to weather will risk forfeiting spots (without refund) at future CAM events. Concord Arts Market takes safety very seriously and may cancel or close an event early in the event of potentially dangerous weather conditions in the forecast. If an event is cancelled or closed early due to weather, the market will not be rescheduled and the registration fee cannot be applied to another market. However, depending on the situation and at the discretion of the CAM producer, partial refunds or future discounts may be considered.

INDEMNIFICATION: Vendors are recommended to have their own general liability insurance. Vendors are solely responsible for damages resulting from the sale of unsafe or unsound goods, in addition to any accidents occurred while at Concord Arts Market events. Vendors agree to indemnify and hold harmless Concord Arts Market, Jessica Livingston (Producer of the Concord Arts Market), City of Concord, Intown Concord, Kimball Jenkins, 7 Eagle Square LLC, as well as their affiliates/employees/agents from any and all liability, loss or damages which may be incurred as a result of all claims, demands, costs, judgments or expenses, including attorney's fees, arising from the vendor's participation in the Concord Arts Market.

PROMOTIONAL MATERIALS: Vendors understand and agree their name, business name, website(s), social media website(s) and any photos, video, item description and prices may be used for promotional use by the Concord Arts Market.

DIVERSITY, EQUITY, ACCESS, INCLUSION: The Concord Arts Market believes in an inclusive environment where all members of our community are welcomed, valued, respected, and heard. We are committed to creating and maintaining an environment that is free from discrimination and harassment.

TENT POLICY: If you are using a tent, you must also provide weights for your tent--at least 25 lbs per tent leg, clearly anchored/attached to your tent by sturdy means, not resting on the feet of your tent. No exceptions.
