



Short Term Mission Trip Participation Agreement Mexico October 13-20, 2026

By signing below, I acknowledge that I have read, understand, and agree to the expectations, guidelines, and financial commitments associated with the Elevate Ministry Mission Trip to Mexico.

Code of Conduct

1. **Purpose & Work Expectations** This is a work-focused mission trip. Every team member—regardless of age—is expected to contribute daily with a willing spirit and positive attitude. Tasks may include cleaning, painting, basic repairs, digging, and other hands-on projects.
2. **Character & Representation** As a participant, I understand that I am representing Elevate Ministry and the Christ-centered values we uphold. I will conduct myself respectfully, lovingly, and with a servant-hearted attitude, prioritizing the needs of the team and the community we are serving.
3. **Substances & Language** I will refrain from using tobacco, tobacco products, drugs, alcohol, and inappropriate, derogatory, or foul language. This includes content displayed or played on electronic devices.
4. **Modest Dress** Modesty is required at all times.
 - Shorts must reach at least mid-thigh.
 - No leggings or yoga pants.
 - Shirts must cover the midriff, even with arms raised.
 - Swimsuits must be modest.
 - Girls: two-piece or tankini allowed only if the midriff is fully covered; swim shorts recommended.
 - Boys: no Speedo-style suits.
5. **Buddy System & Safety**
 - Ages 18 and under: must stay with at least one other person in public places; a group leader must be informed before going anywhere.
 - Ages 18 and over: notify another team member before leaving and avoid going anywhere alone.
 - At the Connections House: participants 15 and older may be unaccompanied inside the facility but must ensure a roommate knows their location.
 - Children 14 and under must remain with a parent at all times.
6. **Respect for Hosts & Facilities** We are guests in Mexico and at the Connections House. I will respect the facilities, staff, and any rules given. I will be mindful of noise levels and considerate of other guests who may be staying on the property.
7. **Team Devotions** Growing in Christ and as a team is part of this experience. All team members are expected to attend the nightly debrief and devotional time.
8. **Daily Schedule** A typical workday may look like this (flexibility may be required):
 - **7:30 AM** – Breakfast
 - **8:30 AM** – Depart for worksite
 - **12:00 PM** – Lunch
 - **5:00 PM (approx.)** – Return for dinner

9. **Gratitude & Growth** I will approach this trip with gratitude, recognizing the privilege of serving others and the opportunity for personal and spiritual growth.
10. **Sharing the Experience** Upon returning home, we encourage you to share what God has done during the trip with others.

Financial Agreement

I agree to make the required payments to Elevate Ministry to cover trip expenses. I understand:

- Funds received are used for the short-term trip
- If donations exceed my trip cost, Elevate Ministry will allocate the excess where needed; no refunds will be issued.
- I am responsible for my own meals and expenses during travel days to and from San Diego.
- Elevate Ministry covers meals and transportation **from** and **back to** the San Diego airport for those arriving and departing within the designated time window.
