

ON-STREET PARKING RESTRICTIONS

Vehicles without residential ID stickers are subject to a ticket if parked on one of the streets named below during the restricted times.

Fox Lake Trustees are in the process of having identification stickers printed for residents to purchase for a nominal fee (to cover the printing costs). We will post more information here as soon as the stickers are available; they should be available by the end of May.

To receive a parking sticker, you must be a resident of Fox Lake. Assessment fees must be up to date and vehicle(s) must be registered in the state of Missouri.

No parking 7:00 a.m. to 12:00 noon school days except residents of Fox Lake subdivision with vehicles properly identified pursuant to Section 1213.100 SLCRO (O. No. 26671, 2-7-17), on the following streets in Fox Lake Subdivision:

- Birkemeier Ct., both sides, from Birkemeier Dr. to its terminus
- Birkemeier Dr., both sides, from Del Lago Dr. to the east intersection with Karsten Dr.
- Bugle Bend Dr., both sides, from the southwest intersection with Bugle Hill Dr. to the north intersection with Bugle Run Dr.
- Bugle Hill Dr., both sides, between its intersections with Bugle Bend Dr.
- Bugle Run Dr., both sides, between its intersections with Bugle Bend Dr.
- Centorbi Ct., both sides, from Birkemeier Ct. to its terminus
- Del Lago Dr., both sides, from New Halls Ferry Rd. to terminus
- Doyne Dr., both sides, between its intersections with Watersedge Dr.
- Fox Crossing Dr., both sides, from Fox Plains Dr. to 230 feet north of Foxtail Dr.
- Fox Island Dr., both sides, between its intersections with Waterfall Dr.
- Fox Plains Dr., both sides, from Del Lago Dr. to Ninety-Fifth Ave.
- Foxtail Dr., both sides, from Del Lago Dr. to Fox Crossing Dr.
- Hounds Hill Dr., both sides, from Fox Plains Dr. to the north intersection with Tera Bera Dr.
- Karsten Dr., both sides, between its intersections with Birkemeier Dr.
- Paschon Ct., both sides, from Del Lago to terminus
- Paschon Pl., both sides, from Del Lago to terminus
- Tera Bera Dr., both sides, between its intersections with Hounds Hill Dr.
- Waterfall Dr., both sides, from Del Lago Dr. to the northwest intersection with Fox Island Dr.
- Watersedge Dr., both sides, from Del Lago Dr. to the north intersection with Doyne Dr.
