SEASONAL CAMPSITES

SEASONAL SITES INFORMATION:

- Sites 1 – 19 are designated seasonal campsites.
- The camp season typically runs between May – September. The Forestry & Recreation Department determines the start and end of the camping season.
- For a complete set of park rules see “**Veterans Memorial Park Rules**”.

SEASONAL SITE FEES: Fees are subject to change

- Sites 1 – 19 are \$2000.00 per season (\$1000.00 deposit)
- Seasonal site fees are based on one (1) camping unit per campsite.
- One additional camping unit other than tents on seasonal sites will be allowed. See park manager for more information.

RESERVATIONS & PAYMENT: Form is available on www.forestcountywi.com

- **New campers** interested in a seasonal site should call the Forestry Department at (715)478-3475 to inquire on availability. Seasonal sites may be renewed each year by the current seasonal camper so site selection may be limited. You can request to be added to a waiting list.
- Steps to reserve a seasonal site:
 - Complete a “**Seasonal Site Reservation Form**”.
 - 50% deposit **REQUIRED** – [Check payable to Forest County Treasurer](#)
 - Return form and deposit to:

 - Reservation form and 50% deposit are due by February 1st of camping season.
- **Remaining balance is due in full upon arrival to campsite.**

SITE SELECTION:

- Site selection will take place once deposit is received.
- Campers have the option to select three (3) sites on the reservation form. Sites preferences are not guaranteed, we will do our best to accommodate requests.
- A letter will be sent to the name and address indicated on the reservation form indicating receipt of deposit and site assignment information.

SEASONAL SITE RENEWAL: See park manager

- Current seasonal site campers have the option to renew their site reservation at the end of the camping season. See park manager to obtain a “Seasonal Site Reservation Form” and indicate you will be back next season.
- Reservation form and 50% deposit are due by February 1st of camping season.

CANCELLATION POLICY:

- Seasonal site reservations must be cancelled by the 1st of April. A refund will be issued with a \$100.00 handling fee deducted. All cancellations after the April deadline will forfeit their 50% deposit.
- To cancel your reservation, call the Forestry & Recreation Department at (715) 478-3474.

OTHER:

- Please limit yard decorations and lights at your site. We encourage the use of mats in front of campers, under tents, canopies, awnings or anything that may sit for an extended period of time. This allows park staff to easily maintain the grounds.
- Please turn AC down and store decorations, toys, lights, awning, equipment, etc., if you leave for an extended period of time. Forest County is not responsible for any loss or damage.
- Guests are welcome! If additional camping units are used, you may be subject to the nightly fee. See park manager.

Campers violating park rules can be subject to immediate removal without refund from the campground and be further subject to denial of future use.
