tank at the water treatment plant.

Project Alternatives: The alternative that has been considered is the no action alternative. This

alternative is not feasible as the tank is part of a larger critical facility that must remain in service to protect the health and safety of the community. The no action alternative is not feasible because forgoing work would also adversely

impact the health and safety of the community.
