Regular Monthly Board Meeting Minutes

The regular monthly board meeting of the Town of Bloomington was called to order on Monday April 5th, at 7:00 pm by Chairman Greg Patterson. Other members present were Town Supervisors William Erdenberger, Joe Kirschbaum, Clerk Jane Patterson and Patrolman Andrew (Buck) Crubel. Public members in attendance were Michelle Newhouse, representatives from Scott's Construction and Fahrner Construction. Motion (Greg Patterson), seconded (Bill Erdenberger) was made to approve posting of the April meeting/agenda notice, motion carried. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to approve the March Board Meeting minutes, motion carried.

There were no Appearances/Public Comments.

Chairman Greg Patterson opened the bids for Crack Filling on Maine Road. Fahrner bid \$11,875.00 (included routing), Scott's bid \$5,775.00 (excluded routing) and Thunder Road bid \$11,000.00 (included routing). Motion (Greg Patterson), seconded (Bill Erdenberger) to table discussion of crack filling to a later time in the meeting, on a voice roll call, yes-3, no-0, motion carried. Chairman Greg Patterson opened the Seal Coat bids. Fahrner bid \$111,043.00 and Scott's bid \$99,998.00. After bid discussion, motion (Greg Patterson), seconded (Joe Kirschbaum) to accept Scott's Seal Coat bid, on a voice roll call, Yes-3, no-0, motion carried. Discussion on crack filling resumed, motion (Greg Patterson), seconded (Joe Kirschbaum) to accept Scott's bid for crack filling, on a voice roll call, Yes-3, no-0, motion carried. Chairman Greg Patterson signed both Crack Fill and Seal Coat contracts with Scott's Construction. There was some discussion about asphaltting our .5 mile of Fairground Rd this year with the Scott's Construction Rep, the board will continue this discussion at the next board meeting.

**Roads:** Roads conditions are good; weight limit signs have been taken down. Two advisory road signs will be placed on Spruce Rd when construction on the cement culvert on State Hwy 133 and Ohio Rd begins.

**Machinery Report:** Patrolman Andrew Crubel reported the machinery is in good working condition.

Clerk Jane Patterson presented the March 2021 financial report. Chairman Greg Patterson and Patrolman Andrew (Buck) Crubel will contact Henderson and Truck County about the Henderson bill for chain. The Spring Election is tomorrow, all board members and the treasurer are on the ballot. There are no registered write ins.

The Town's Annual Meeting will be held Tuesday, April 20<sup>th</sup>, 2021 at 7:00 pm at the Town hall. The next regular Board Meeting will be Monday, May 3<sup>rd</sup> at 7:00 pm at the Town Hall. The first Board of Review meeting will be called to order on Monday, May 3<sup>rd</sup>, 2021 at 6:45 pm at the Town Hall to immediately adjourn to a later date.
