Regular Monthly Board Meeting Minutes

The regular Monthly Board Meeting of the Town of Bloomington was called to order on December 6th, 2022 at 7:00 pm by Chairman Greg Patterson. Other members present were Town Supervisors Bill Erdenberger, Joe Kirschbaum, Clerk Jane Patterson and public member Michelle Newhouse. Patrol Andrew (Buck) Crubel was not present. Motion (Greg Patterson), seconded (Bill Erdenberger) was made to approve posting of the December meeting/agenda notice, motion carried. Motion (Greg Patterson), seconded (Bill Erdenberger) was made to approve the November Monthly Board Meeting Minutes, motion carried. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to approve the Budget Hearing minutes, motion carried. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to approve the Special Town Meeting minutes, motion carried

**Roads & Machinery Reports:** Roads are in good condition. J&N Stone graveled Hickory Road from the Myers Quarry to the edge of the seal coat. J&N will not charge the Town for this gravel since they will be excavating the quarry and the using the road. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to keep the charge for plowing private driveways at last year's price of \$25.00 per plowing. Patrolman Buck Crubel will determine if an additional charge needs to be added due to the amount of plowing or adding grit. Machinery is in good condition. The grader is leaking antifreeze from the compressor pump, Fabick has been notified and will come to check it. Motion, (Greg Patterson), seconded (Joe Kirschbaum) was made to increase last year's [year-end] bonuses by 12%, on a voice roll call, yes-3, no-0, motion carried. The board approved the purchases of a battery powered chain saw and new tire chains for the trucks. Patrolman Buck will order these items.

**Financial Report:** Clerk Jane Patterson presented the November 2022 financial reports. There were no outstanding bills. The Town Referendum regarding the appointment of the Treasurer's position passed Yes-115, No-51. Motion (Greg Patterson), seconded (Bill Erdenberger) was made to accept and adopt the 2023 Town Budget, on a voice roll call yes-3, no-0, motion carried. The board discussed the end of the year account balances and agreed that any surplus funds at the end of December 2022 will be placed in the Infrastructure Fund Account. The date for Caucus will be January 2<sup>nd</sup>, 2023 at 6:30 pm. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to accept the Gardiner Appraisal Service LLC Contract, on a voice roll call yes-3, no-0, motion carried.

Patrolman Buck has installed the exit lights.

**Future Meetings:** The next regular Monthly Board Meeting will be held on Monday, January 2<sup>nd</sup>, 2023 at 7 pm and the Caucus Meeting will also be held on January 2<sup>nd</sup>, 2023 at 6:30 pm, both meetings at the Town Hall.
