Wednesday June 7th, 2023
Regular Monthly Board Meeting Minutes

The regular Monthly Board Meeting of the Town of Bloomington was called to order on Wednesday June 7th, 2023 at 7:00 pm by Chairman Greg Patterson. Other members present were Supervisors Bill Erdenberger and Joe Kirschbaum, Clerk Jane Patterson, Treasurer Brenda Kluesner, Patrolman Andrew (Buck) Crubel and public member Mike Patterson. Motion (Greg Patterson), seconded (Joe Kirschbaum) was made to approve the posting of the June 7th, 2023 meeting/agenda, motion carried. Motion (Greg Patterson), seconded (Joe Kirschbaum) was made to approve the May 1st, 2023 meeting minutes, motion carried.

Appearances and Public Comments: There were no appearances or public comments.

Roads and Machinery Reports: Patrolman Crubel is getting roads ready for seal coat which will take place mid to late June. The shoulder on Maine Road have been graded. Road Ratings for the DOT need to be done this year-due by Dec. 15th. Machinery is in good condition. Patrolman Crubel reported that the loader tractor will need new tires by the end of the year and the grader will need tires within the next two years. The board will wait until the end of the year to see if funds are available for the purchase of the tractor tires. The board agreed to allow Patrolman Crubel to purchase a new grease gun and a few green strobe lights for the plow trucks. Crubel explained that the county is going from the amber strobe to the green strobe for improved visibility.

Financial Report: Treasurer Brenda Kluesner presented the May 2023 financial report. Motion (Greg Patterson), seconded (Bill Erdenberger) was made to approve the financial report. Clerk Jane Patterson reported that there were no outstanding bills. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to approve the Liquor License renewal application and issue a liquor license to Blake Hollow Barn, on a voice roll call, yes-3, no-0, motion carried. Motion (Greg Patterson), seconded (Joe Kirschbaum) was made to approve three Operator's License to Sell Alcoholic Beverages to Cassie Myers-Knapp, Wendy Myers, and Bridgette Myers, on a voice roll call, yes-3, no-0, motion carried. Motion (Joe Kirschbaum), seconded (Bill Erdenberger) was made to grant Fred Mumm a driveway permit out on Walnut Bluff Road, on a voice roll call, yes-3, no-0, motion carried.

Chairman Greg Patterson read his letter of resignation as Town of Bloomington Chairman, effective immediately following adjournment, to the board and all others present. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to accept the letter of resignation. Greg and Jane Patterson have moved into a new home in the Beetown Township. Following the motion, Bill Erdenberger presented Greg Patterson with a plaque of recognition for his 21 years of service to the Town as Supervisor and Chairman.
