Township of Bloomington Monday June 3rd, 2019 Regular Monthly Board Meeting Minutes

The regular monthly board meeting of the Town of Bloomington was called to order on Monday June 3rd, 2019 at 7:00 PM by Chairman Greg Patterson. Members present were Chairman Greg Patterson, Town Supervisors William Erdenberger & Joe Kirschbaum, Clerk Jane Patterson, Patrolman Andrew Crubel, and public member Michelle Newhouse. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) to approve posting of the June meeting/agenda notice, motion carried. Motion (Greg Patterson), seconded (Bill Erdenberger) to approve the May Board meeting minutes, motion carried.

Buck Crubel spoke during the public comment time stating that Amaris Mergen would like either a bus stop ahead or children at play sign posted near their farm. The board will look into it.

Patrolman Crubel said that he has not heard anything from Scott's Construction as to when they will do the seal coating. Kerry Thornton asked if the board could order gravel for her driveway; Michelle Newhouse asked if the board could order gravel for down at Jay's Landing. The grader needs a few repairs and Andrew Crubel is getting the mower ready to cut the road banks. When mowing is completed, Price's will look at the loader tractor to see why the loader never had a floater installed for the bucket. The black truck needs Freon, AC is not working; the orange truck is still up at Tyler's Repair. Motion(Greg Patterson), seconded (Joe Kirschbaum) to hire Kyle Adrian for, as needed, part time summer help, on a voice roll call, all in favor, motion carried. Motion(Greg Patterson), seconded (Bill Erdenberger) to pay Kyle \$12.00 per hour, on a voice roll call, all in favor, motion carried.

Clerk Jane Patterson presented the May financial report. Clerk Jane Patterson attended the Grant County Board meeting in Lancaster on May 21st, Command Central demonstrated the two new voting machines being considered for purchase by the County. The Municipalities will be responsible for the full cost of the new voting machines with financing available. Our County Clerk suggested in an email to all clerks that Municipalities could combine Polling Places so only one machine would have to be purchased between those Municipalities. This option would work best for smaller municipalities.

The Board discussed Short Term Rentals (Tourist Rooming House-TRH) located out on Mississippi Lane. Clerk Jane Patterson has received a sample Ordinance from the Wisconsin Towns Association regarding Short Term Rentals. Jane will bring the ordinance to the July Meeting for the Board to look over.
